DISCUSSION ITEM

Proposed 9 Axle Log Truck

Chair MacDougall reported that the Ministry of Transportation and Infrastructure has issued permits for 9 Axle Log Trucks on Highway 27 and the North Road a secondary road north of Fort St. James.

Director Miller spoke with Ministry of Forests, Lands and Natural Resource Operations (MoFLNRO) regarding engagement during the investigation process in regard to the proposed 9 axle log truck configuration. He noted that there did not appear to be consultation. There has been numerous configuration changes in regard to log haul trailers in the past years. Some changes have impacted the ability for the trucks to maneuver around and through corners on Forest Service Roads.

Staff will contact Rob Phillips, Engineering Officer, Authorizations, Nadina, MoFLNRO, in regard to the impact of 9 axle log trucks on Forest Service Roads.

Director Lindstrom spoke of concerns in regard to the ability of the truck tractor being capable of pulling the loaded 9 axle log truck. Concerns were also brought forward in regard to the possible damage caused to the road systems and the cost to tax payers to repair the roads. Director Greenaway noted that Highway 27 was paved in the summer of 2015 and the edges of the road are already breaking away.

Log truck load sizes pre-mountain pine beetle were smaller due to the weight of green wood. As the mountain pine beetle wood become the focus, load sizes increased in volume to maintain the same weight on a load. Due to the impacts of the midterm timber supply and the removal of the mountain pine beetle wood there will be a return to pre-mountain pine beetle weights but with the increase to a 9 axle log truck the volume will not decrease. Concerns were discussed regarding the consequences of utilizing a 9 axle log truck.

Chair MacDougall intends to contact Jason Fisher, Director, Forest Sector Strategies, Competitiveness and Innovation Branch, MoFLNRO.

Wildfire Symposium Follow Up - February 29, 2016

Director Miller provided an overview of the Wildfire Symposium Follow Up on February 29, 2016. He noted that there was very good discussion and that there is a commitment from all the stakeholders to move forward. The Ministry of Forests, Lands and Natural Resource Operations and Wildfire Management Branch indicated budget considerations have been made to continue to move forward.

Discussion took place regarding the Forest Enhancement Society of BC and possible funding opportunities. Further information is required in regard to the society and a future meeting will be scheduled once information is obtained in regard to the Forest Enhancement Society of BC. A tentative meeting date has been scheduled for April 5, 2016.

Director Miller noted that there is a commitment from each organization to have one person be part of the working group at a staff level and that either Chair MacDougall or himself will provide a political connection.

<u>BC Government News – B.C. Increases Investments in Forest</u> Stewardship

Director Petersen noted that the FireSmart program for home owners is very beneficial but mentioned that many rural residents do not have the equipment or resources to fire smart their property.

Director Miller noted that there have been gaps identified in regard to rural residents accessing/utilizing equipment and or contractor to complete fire smart work.

Discussion took place regarding the Regional District of Bulkley-Nechako including on its Business Directory web page a contractors list that can complete fire smart work for rural home owners.

Discussion took place regarding funding for private land hazard reduction. Staff will further investigate possible funding options.

Prince George - Comments are being accepted until May 24, 2016, on a discussion paper released today as part of a comprehensive timber supply review for the Prince George Timber Supply Area.

Public feedback on the discussion paper will be considered by the chief forester before setting the new allowable annual cut. The discussion paper provides the results of the timber supply analysis, including a base-case harvest forecast. It also describes the geography, natural resources and current forest management practices in the Prince George Timber Supply Area.

The Prince George Timber Supply Area, the largest in the Province, covers approximately 7.97 million hectares in the north-central portion of the province, with approximately 3.1 million hectares available for timber harvesting.

The City of Prince George is the largest community in the timber supply area which includes the municipalities of Vanderhoof and Fort St. James and Village of Fraser Lake, as well as several smaller unincorporated communities.

The chief forester's allowable annual cut determination is an independent professional judgment based on information such as technical forestry reports and input from First Nations and the public.

In April 2015, the Province and seven Carrier Sekani First Nations, whose territories encompass the Prince George Timber Supply Area, signed an agreement which provides a framework to deepen collaboration on a range of issues – including allowable annual cut decisions.

Government has been consulting with First Nations throughout this timber supply review regarding the potential impacts of the chief forester's allowable annual cut determination on First Nations interests.

Under the Forest Act, the chief forester must determine the maximum amount of wood that can be harvested in each of the province's 38 timber supply areas and 35 tree farm licences at least once every 10 years. However, a new allowable annual cut may be determined earlier in response to abnormal situations, or the current allowable annual cut postponed for up to five years if it is not expected to change significantly.

British Columbia government acting on spruce beetle

Prince George - In response to recent increases in the spruce beetle population, the Ministry of Forests, Lands and Natural Resource Operations is committing \$1 million and has designated a spruce beetle manager to work with First Nations, local communities and stakeholders to develop a regional spruce beetle management plan.

The spruce beetle (Dendroctonus rufipennis) is a common forest pest that normally feeds on the inner bark of weakened or fallen spruce trees, but is capable of killing healthy trees if the infestation is sufficiently serious and prolonged. Spruce beetle outbreaks occur regularly in British Columbia and have historically lasted up to seven or eight years.

The current infestation has affected 156,000 hectares of forest in the Omineca region, specifically the eastern valleys of the Mackenzie timber supply area and northern portions of the Prince George timber supply area. This is a significant increase from the 7,653 hectares affected in 2013 and is the largest spruce beetle outbreak since the 1980s.

Recent weather patterns, including warm springs, dry summers, warm winters and windstorms (resulting in more tree blowdowns), have contributed to the increase in spruce beetle populations in the region. The Chief Forester is monitoring the situation to help ensure a balance between maintaining the mid-term timber supply, requirements of other resource values, such as wildlife habitat and the need for sanitation control of the spruce beetle.

The insects are native to British Columbia, so it's not unusual to see them in the province's forested areas. The Omineca region contains 9,018,763 hectares of forest; with 4,728,782 hectares available for logging.

The funding of \$1 million for 2016-17 is in addition to the \$850,000 the ministry spent on spruce beetle detection activities in 2015-16. Aggressive control activities include a focus on sanitation logging on the timber-harvesting land base and use of "trap" trees in areas outside the timber-harvesting land base, such as wildlife habitat areas, or areas that are uneconomic to harvest.

Heather Wiebe, resource manager in the Mackenzie Natural Resource District, has been designated as the Omineca spruce beetle project manager. She will be forming a public advisory committee that will work with stakeholders, communities and First Nations to represent the environmental and social values the forests of Omineca provide. This will complement forest licensees' suppression plans.

I'm confident that with all groups working together, we will be able to do so."

Quick Facts:

- The Mackenzie Timber Supply Area and the Prince George Timber Supply Area were both assessed during the ministry's "aerial overview survey" in the summer and fall of 2015.
- Aerial assessments and ground surveys are both being used to identify affected stands of spruce trees.
- Ministry staff are also investigating how remote sensing technology could be used to detect and map affected areas.
