
#### **Reuse Shed Rules**

- 1. Attendant has final say in determination of acceptability of items in reuse shed.
- 2. All items must be inspected by the reuse shed attendant prior to placement in the reuse shed.
- 3. Items are to be dropped off only during times reuse shed is open and staffed.
- 4. No loitering maximum 15 minutes/visit, no more than 2 visits/day unless dropping items off.
- 5. Children and pets are to remain in vehicles at all times.
- 6. No aggressive behaviour or foul language will be tolerated.
- 7. Mass purging of the reuse shed by the public is prohibited.
- 8. No smoking, drug use or alcohol consumption while on RDBN property. Members of the public arriving at the reuse shed facility appearing to be under the influence of drugs or alcohol will be asked to leave the site immediately.



# The reuse shed is made available on the following terms and conditions:

- ⇒ Use of the reuse shed is done solely at the person's own risk;
- ⇒ The person using the reuse shed is fully responsible for their own safety and wellbeing.
- ⇒ The Regional District does not warrant or guarantee the cleanliness or condition of any item in the reuse shed. Any risk or liability associated with the taking of an item from the reuse shed is the sole responsibility of the reuse shed user;
- ⇒ The Regional District accepts no responsibility for any accident or injury that may occur to any person or personal property of the person while at the solid waste management facility for the purpose of use of the reuse shed.

#### What can I bring??

### Items for placement in the reuse shed <u>must:</u>

 Be clean and in good/ reusable condition.





2. Electronic devices must be in working order.



#### What is not accepted??

#### **Prohibited Materials:**



- 1. Hazardous/toxic materials (e.g. needles, medication, pesticides, cleaning products, ammunition, cosmetics).
- Pornographic magazines and personal pleasure items intended for adult use.
- 3. Broken, damaged or soiled items.
- 4. Liquids.
- 5. Food.
- 6. Mattresses.



- 7. Couches, loveseats or other fabric upholstered furniture.
- 8. Items with safety certifications (e.g. car seats, booster seats, helmets, etc.).
- 9. Children's cribs, cradles, strollers, playpens, safety gates or enclosures, high chairs, infant bath seats and bath rings or other items with safety standards.



#### So they won't accept my stuff....

If an item isn't able to be left at the reuse shed, you might be able to recycle it!

End-of-life programs are available for the following items:

Electronics (Televisions, stereos, computer equipment, cameras, phones (cellular & non-cellular) and video gaming equipment)





Small
 appliances and power tools
 (kitchen countertop appliances, vacuums and personal grooming tools, circular saws and drills)

There isn't a depot for electronics or small appliances in Fort St.

James at the moment. If you're headed to Vanderhoof, Nechako

Valley Secondary School Bottle Depot will take your electronics. If you're headed to Prince

George, the PG Recycling and Return-It Centre will take your small appliances and power tools. The more we can recycle, the less that lands up in our landfills!!

Automotive batteries are accepted at the Fort St. James Transfer Station, as well as Riverside Repairs.



Used oil & filters and used antifreeze can be returned to Riverside Repairs as well. Tires can be taken to Kal Tire.
