apportionment update

Background

The Board of the Regional District of Bulkley-Nechako has given first three readings to "Regional District of Bulkley-Nechako Regional Public Transit and Para-Transit (Highway 16) Service Establishment Bylaw No. 1790, 2016".

Proposed Service

A new Regional Para-Transit Service is proposed. If approved, MoTI has committed to covering 100% of the capital cost of three buses and 2/3 of the operating costs of this service for a period of five years. In addition, MoTI has committed to funding a regional transit coordinator position for three years.

<u>Participating Area</u>: the Town of Smithers, the Village of Telkwa, the District of Houston, the Village of Granisle, the Village of Burns Lake, the Village of Fraser Lake, the District of Fort St. James, and the District of Vanderhoof.

Proposed Requisition and Funding Formula

The maximum annual municipal requisitions are \$90,000. For apportionment among the participating areas, the bylaw provides as follows:

7.Apportionment

In accordance with section 380 of the Local Government Act, the costs of providing the service will be apportioned among the participating areas based on the following formula:

Participant Population (A) x Benefit Factor (B) = C C (for each participant)/ TOTAL C = % requisition for each participant

Where population is based on the most recent BC Stats Population Estimates; and

Where the benefit factor for on-corridor participants is 5 and the benefit factor for off-corridor participants is 1.

In the staff Report presented to the Board for the meeting of December 15, 2016 the following calculation was provided, based on the BC Stats Population Estimates for 2015 and the resolutions of the respective municipalities:

The apportionment to the participating areas, based on the updated BC Stats Population Estimates for 2016 is presented in the table below. The maximum contributions that the RDBN can requisition based on the bylaw are included for reference, as are the draft budget numbers being considered for the RDBN 2017-2021 five year financial plan.

Please note that the Total Requisition is based on the total draft budgeted expenses, net of draft budgeted provincial funding contribution, funding partner contributions, user fees (fares), and grants.

Factors that could impact these draft amounts include but are not limited to:

- changes to the funding formula or other service establishment bylaw changes
- changes in population relative to other municipalities in the service
- Inflation
- Revenue from fares
- maintenance costs of stops including vandalism
- contributions from First Nation funding partners
- unexpected costs insurance claims, legal, etc.

This new service will appear on property tax requisitions from the RDBN to the municipalities by April 15, 2016. Therefore, this will be not be included in municipal budgets, just the RDBN budget.
