RDBN Updated Solid Waste Management Plan Released for Public Consultation

The Regional District of Bulkley-Nechako is asking for public input on the proposed Solid Waste Management Plan update which lays out the future of municipal solid waste (recycling, organics, and garbage) management in the region.

The process to update the plan started in 2017 with a review of the infrastructure and programs we use to manage municipal solid waste. A Regional Solid Waste Advisory Committee was formed in early 2018 to represent communities and groups throughout the region in accordance with provincial guidelines from the Ministry of Environment and Climate Change Strategy. Public input was collected through a public survey in December 2017.

The results of the survey and various technical documents were presented for discussion to the Advisory Committee over the past five months. The proposed plan was developed out of the conversations and input from the Advisory Committee, RDBN staff, and consultant recommendations.

On May 24, 2018, the Regional District of Bulkley-Nechako's Board of Directors endorsed the proposed Solid Waste Management Plan to go out for public consultation. The consultation process will include several opportunities for members of the public and stakeholders to provide input and feedback on the plan throughout the month of June. Regional District staff and consultants will be presenting the plan to municipal and First Nation councils with public input sought through public meetings and an online survey.
