

COMMENTS:

This is a referral from the Province for a Mines Act - Notice of Work Permit for mineral exploration purposes. The proposed term of the application is 5 years. The application area is approximately 310 ha in size while the proposed disturbed area is 3.14 ha in size. According to the application some of the tenure includes previously mined areas.

The application area is located on Manson Creek where it diverges from Dunne Creek approximately 118 kilometres north of Fort St. James. According to our mapping records there are no residences in the vicinity of the permit area.

The applicant is also applying to the Province for a Free Use Permit under the *Forest Act* and a Water License. The proposed activities include access roads, trails, heli pads, air strips and boat ramps, camps staging areas, placer operations, settling ponds and water supply.


