New Initiative:	Yes, this is something we have not done before and no funds have Been set aside for this initiative.		
Goods or services being purchased:	Replacement of our emergency lighting, including battery packs and lights. Total of 26 units.		
How will this initiative help reduce liability or property claims?	Replacing the emergency lighting units will allow light for a longer period of time (30-60 minutes) in the event of power-outages.  The quality of the light will be improved with the replacement. Increasing visibility during periods of non-emergency power outages will allow patrons to comfortably shower and get dressed out of their wet bathing clothing before leaving the building. This will decreases patron stress and increases comfort. Having emergency lighting in-place during all power-outages (especially during winter months when day-light is reduced) will also reduce the risks of slips and falls and help staff implement evacuation procedures and clear the building.

Business Façade Program

The deadline to apply for Business Façade funding was June 30, 2018. This first intake was focused on businesses along Highway 16 as priority. Staff visited businesses along Highway 16 and informed them of the Business Façade funding as well as provided application packages. In addition posts were made on social media and the information was uploaded to the website.

Two applications were received. One did not qualify for funding and the second was Honeysuckle Garden Centre who is eligible for \$2,500 in funding. Honeysuckle intends to paint the store, add signage and add a covered entrance to the store.

As there was not the uptake anticipated from Highway 16 businesses, Staff are recommending that the program be opened up for all eligible businesses in the rural areas. Staff will visit business wherever possible to bring the information packages, will post on social media and in the economic development newsletter.

Whereas there is a critical need to plan for wildfire and take action to reduce the risk to residents, and the Report and Findings of the BC Flood and Wildfire Review recommended that the Government of British Columbia expand the community forest program to communities where interest and capacity exist;

STATUS OF WORK: Construction to date appeared to be in general conformance with the Issued for Construction drawings. The following is a list of observations, comments, and work progress made while on-site.

#### **True Consulting Work Tasks:**

- Completed quality assurance during construction of the new water system.
- Prepared alignment change on Alexandra Street to avoid installing the watermain underneath a property-owner's fence.
- Assisted the Contractor with tools to close valves during a watermain break event.

#### <u>Infracon Work Tasks:</u>

- o Installed watermain along 5<sup>th</sup> Avenue to Alexandra Street, and completed install on Alexandra Street to 6<sup>th</sup> Avenue.
- Removed existing trees and brush on Alexandra Street, and hauled off-site.
- Earthworm Drilling on site completing new water service installs for far side services and the long service line off of Corporation Street.
- Completed Hydro Vac excavation along 5<sup>th</sup> Avenue west of Alexandra Street to confirm existing watermain alignment and depth.
- Started install of watermain from 6<sup>th</sup> Avenue at Corporation Street, working west towards Royal Street.
- Installation of water services on 5<sup>th</sup> Avenue and Royal Street.
- Completed repair of existing AC sanitary sewer pipe on Royal Street near Royal Apartments.
- Continue watering and cleaning roads within the construction area.

#### **Delays/Work Interruptions:**

- The drilling crew cracked the existing 100mm dia. AC watermain on Corporation Street at approx. 4:00pm on July 3<sup>rd</sup>. Backfill and pipe crew were able to repair watermain on Corporation Street and water was restored at approx. 6:30pm.
- During the work on Royal Street on July 5<sup>th</sup> to re-expose the existing sewer main and water crossing, and the crew found the existing AC sewer main was cracked and had to complete a repair on the AC main. The repair was completed on July 6<sup>th</sup>.

On July 6<sup>th</sup>, at approx. 10:10am the pipe crew hit an existing 100mm AC watermain on 6<sup>th</sup>
Avenue. The Contractor completed repair of the existing water main and water was
restored the residents at 12:30pm.

#### **Extra Work Claims:**

 No extra work claims were brought forward by the contractor. However, future claims were discussed regarding the watermain break at Corporation Street and the sewer main break on Royal Street.




FIGURE 9 - CRACKED AND LEAKING AC SEWER MAIN ON ROYAL STREET

#### Re: Reasons for Decision - North Panel Panel, Resolution #164/2018

This is further to the Agricultural Land Commission's letter dated May 28, 2018 which forwarded the *Reasons for Decision of the* North Panel, recorded as Resolution #164/2018. In the letter the Commission advised as follows:

Please note that pursuant to s. 33.1 of the Agricultural Land Commission Act, the Chair may direct the executive committee to reconsider any panel decision if, within 60 days from the date of this decision, he considers that the decision may not fulfill the purposes of the commission as set out in s. 6, or does not adequately take into consideration s. 4.3.

You will be notified in writing if the Executive Committee is directed to reconsider your decision. The Commission advises you to take this 60 day period into consideration prior to proceeding with any actions upon this decision.

I am writing to advise you that Commission Chair, Mrs. Jennifer Dyson, has reviewed the Reasons for Decision of the North Panel, recorded as Resolution #164/2018 and has referred this matter to the Executive Committee of the Commission under s. 33.1 of the Agricultural Land Commission Act (the "ALCA") which provides the following:

#### Reconsideration of decisions of panel

- 33.1(1) The chair of the commission may, in writing, direct the executive committee to reconsider a decision made by a panel established under section 11(1) respecting an application or other matter allocated to the panel by the chair of the commission, including a panel's reconsideration of a decision under section 3(1), if
  - (a) the chair considers that the decision
    - (i) may not fulfill the purposes of the commission as set out in section 6, or
    - (ii) does not adequately take into consideration the considerations set out in section 4.3, if applicable, and
  - (b) the chair makes the direction to the executive committee within 60 days of the decision being made.



- (2) If the chair of the commission directs the executive committee to reconsider a decision under subsection (1), the chair must give notice of the reconsideration to any person that the chair considers is affected by the reconsideration.
- (3) If the chair of the commission directs the executive committee to reconsider a decision under subsection (1), the executive committee must confirm, reverse or vary the decision.
- (4) For the purposes of subsection (3), the executive committee has all the powers, duties and functions of the commission.
- (5) A decision by the executive committee under subsection (3) is for all purposes a decision of the commission.

The Chair has directed the reconsideration on the basis that he considers that the Decision may not fulfill the purposes of the Commission as set out in section 6 and that the decision does not adequately take into consideration the considerations set out in section 4.3, the latter of which apply in Zone 2. The Chair has also directed me to make clear that this referral to the Executive Committee under s. 33.1(1) is just that, a referral, and does not represent the Chair's final conclusion on the proper outcome of the reconsideration. The final decision by the Executive Committee (consisting of the Chair and the 6 Vice-chairs of the Commission) will be made by the Executive Committee with each member being responsible for exercising their independent judgment as part of the Executive Committee as a decision-making body after deliberation, discussion and consideration of all the information, evidence and submissions.

The Executive Committee will consider the reconsideration at the first available meeting opportunity.

#### Dear Mr. Bekhuys:

This letter provides an overview of the work undertaken in considering New Gold Inc. (New Gold) effects assessment for caribou for the proposed Blackwater mine project (Blackwater) as well as what the Environmental Assessment Office (EAO) expects New Gold to submit as part of the revised assessment and considerations for habitat offsetting.

The EAO wrote New Gold on March 3, 2017 and on December 5, 2017, regarding the EAO's outstanding comments on New Gold's assessment of Blackwater's effects on Southern Mountain caribou (SMC). The comments raised by the EAO centred on the accuracy of the effects assessment, the assumptions used by New Gold in the mapping of caribou habitat, and New Gold's assessment of cumulative effects.

New Gold provided a response to those comments on December 5, 2017. The EAO responded on December 20, 2017 that New Gold's submission did not address the information required by the EAO. Rather than reiterating the comments, the EAO committed to working with the Canadian Environmental Assessment Agency (the Agency), The Ministry of Forests, Lands, Natural Resource Operations and Rural Development (FLNRORD), Environment and Climate Change Canada (ECCC), and Indigenous Groups (Lhoosk'uz Dene Nation, Ulkatcho First Nation, Nadleh Whut'en First Nation, Saik'uz First Nation, and Stellat'en First Nation) to provide clarity to New



Gold in the information required by the EAO to assess the nature and extent of the impacts of Blackwater on SMC.

Since that time, the EAO has worked closely with those parties in a series of discussions. This work was informed by a field trip to the Project site (April 18, 2018) to confirm characterisation of the caribou habitat affected by Blackwater and subsequently the mitigations and offsetting proposed by New Gold.

On April 24, 2018, FLNRORD and ECCC provided a verbal overview of their shared view on the characterization of critical habitat in the project area. FLNRORD and ECCC have determined that "the mine site footprint falls within Matrix Type 1 critical habitat with high elevation attributes, and there is high elevation winter range at the top of Mount Davidson that is outside the mine site footprint but within a disturbance buffer". With this shared view on the critical habitat in the project area, FLNRORD and ECCC were able to complete their technical review of the information provided in New Gold's March 16, 2018 submission. This resulted in technical comments from FLNRORD and ECCC which were shared with New Gold as well as with the EAO Blackwater Advisory Working Group (AWG) by email on May 28, 2018.

Those comments are also included as the following appendices to this letter:

- II. FLNRORD Comments on Mitigation and Offsetting
- III. FLNRORD Comments on Critical Habitat Mapping
- IV. Addendum to FLNRORD Comments on Critical Habitat Mapping

The EAO/Agency subsequently arranged a meeting with a sub-group of the Blackwater AWG on June 11, 2018 to discuss the comments and provide further clarity to New Gold in developing a response.

#### EAO expectations regarding revised caribou effects assessment:

The expectations laid out below are based on the comments provided by FLNRORD, and ECCC and from discussions at the Blackwater caribou sub working group meeting of June 11, 2018. They are also consistent with my discussions with New Gold over the past several weeks.

Considering the ECCC and FLNRORD comments, the EAO expects New Gold to provide an updated assessment of the direct, indirect, and cumulative effects of Blackwater on SMC and critical habitat, and identify additional measures to mitigate those effects. This is to include the following:

 Consideration of the changes made to Blackwater during the EA to avoid and minimize impacts to caribou, including changes to project components and activities, and the duration of these, and their effects to caribou.

- 2. A descriptor of how caribou habitat is now viewed where Blackwater components are located, along with an appropriate-scale map identifying that habitat within the project area as well as within the 500 m buffer suggested by FLNRORD.
- 3. Updated areas of spatial overlap between the project area and the types of critical habitat as well as within the 500 m buffer suggested by FLNRORD.
- 4. The current state of caribou habitat within the local population unit (LPU) as well as the current status of past, present and future projects that may interact cumulatively with Blackwater.
- 5. A description of the proposed mitigation measures broken down by caribou habitat type, by type of effect (direct or indirect).
- 6. A revised effects assessment and significance determination for direct as well as cumulative effects to SMC and its critical habitat, taking into account the characterization of critical habitat in the project area and the 500 m buffer.
- Additional measures to mitigate the effects to SMC resulting from effects to critical habitat. Both habitat-based and non-habitat measures should be considered.

In determining the adequacy of the information required above, the EAO will be consulting with the AWG and Indigenous Groups. As Blackwater is undergoing a cooperative EA with the Agency, the EAO will be coordinating with the Agency in the development of a revised work plan and review schedule.

The Blackwater EA is temporarily suspended as of August 15, 2016 at New Gold's request. Consistent with the EAO letter of January 17, 2018 the suspension will remain in effect until the EAO has completed the assessment of all of the Valued Components and is satisfied that the assessment of potential adverse effects and the information needed for a decision by Ministers on the Application for an Environmental Assessment Certificate is complete.

EAO will be posting this letter as well as sharing directly with the AWG so they are aware and prepared to engage in the review. There may be additional expectations from the AWG which I will forward as appropriate.
