REPORTS

Allocation of Costs

Director Petersen expressed his concerns in regard to the costs and taxation increases to implement regulations imposed by the provincial government for small rural fire departments. He is not in support of cost increases in regard to the Cluculz Lake Volunteer Fire Department.

Chair Benedict mentioned the possibility of bringing the issue forward at the North Central Local Government Association Conference in Dawson Creek on May 4-6, 2016. Director Miller spoke of the past lobbying of the RDBN regarding the impacts to small rural fire departments in regard to the provincial process and new regulations in the "British Columbia Fire Service Minimum Training Standards Structure Firefighters Competency and Training Playbook".

Discussion took place in regard to the funding allocations for the rural fire departments. The differences between the Cluculz Lake Volunteer Fire Department and the other rural fire departments was discussed. Cluculz Lake Volunteer Fire Department is operated by a society and the society is responsible for training thus the contribution service does not allocate funding for training.

The RDBN hosted a meeting attended by the rural fire departments in regard to the allocation of administration costs and changes to the training regulations required by provincial regulations. Director Miller noted that in discussions with Regional District of Fraser-Fort George they are experiencing the same challenges with the small rural fire departments within their region.

The future of rural fire departments and the consequences associated with a rural fire department not being able to collect sufficient funds to provide a service was discussed.

Discussion took place regarding current costs associated with managing fire departments being allocated to Protective Services. Costs associated with a fire protection service need to be funded by that service under the *Local Government Act*.

Discussion took place in regard to volunteer fire department member's commitments and scheduling issues to fulfill regulatory training requirements. Alternate Director Hughes spoke of the recruitment drives that have occurred in his area and the commitment of the volunteer fire department members to be continually recruiting volunteers.

Alternate Director Hughes noted that a resident within a fire protection boundary's overall costs, including both home insurance and the rural fire protection service, would be less than a resident outside a fire protection boundary.

Subject: NWIPC Funding for 2016

In 2015, the annual funding amount that was committed to the Northwest Invasive Plant Council (NWIPC) was \$43,000. To make management of invasive plant control more efficient, the NWIPC divides the RDBN into three invasive plant management areas (IPMAs): Nechako IPMA (Areas C, D and F), Lakes District IPMA (Areas B & E) and the Bulkley IPMA (Areas A & G). The funding was distributed equally among the three IPMAs and that the distribution of funds be was to 85% for on-the-ground work and a maximum of 15% for administration.

In 2015, \$36,751.74 was spent by the NWIPC for invasive plant management services leaving \$6,248.26 of unspent monies. Please see attached letter from the NWIPC which describes why all of the committed funds were not spent. The NWIPC has requested that the funding commitment of \$43,000 be maintained for the 2016 year. The NWIPC has further requested that an additional \$500 be contributed towards the pooled Education & Awareness fund. These funds will be used for the purchase of up-to-date print material and display items to educate the public and provide awareness of invasive plants in the North West.

It is recommended that the funding level of \$43,000 be continued for the 2016 year, that the funding be distributed equally among the three IPMAs and that the distribution of funds be 85% for on-theground work and a maximum of 15% for administration. It is also recommended that an additional \$500 be contributed towards NWIPC's Educational & Awareness bringing the total of RDBN committed funds of \$43,500 for the 2016 year.

RECOMMENDATION

(All/Directors/Majority)

1. That the Rural Directors Committee receive the memorandum titled, "NWIPC Funding for 2016" and dated February 26, 2016.

2. Further, that the Rural Directors Committee recommend to the Board of Directors that the 2016 funding contribution to the NWIPC be continued at a value of \$43,000, that the funding be divided equally between each IPMA and that the distribution of funds be 85% for on-the-ground work and a maximum of 15% for administration.

3. Further, that the Rural Directors Committee recommend to the Board of Directors that the request for an additional \$500 be contributed to the NWIPC's Education & Awareness pooled funds.

Re: Request for Funding Commitment for Invasive Plant Management

The Northwest Invasive Plant Council (NWIPC or the Council) thanks RDBN for the funding received in 2015 and their participation on the NWIPC Board of Directors. In 2016, we will be entering the third year of the "partnership funded" model through which partners allocate funding specific to their jurisdictions.

NWIPC is requesting a 2016 commitment from the RDBN Board of Directors for \$43,000 for "on-theground" IPM. The Council is also requesting that the Board consider an \$500 contribution to a pooled Education and Awareness fund. NWIPC performs many outreach and education activities requiring the purchase and/or development of up to date print materials and display items. These items are consumables that require replacement. It is education and outreach to your constituents which leads to the prevention of invasive plants becoming established in your region.

In 2015, RDBN gave NWIPC a budget for the commitment of \$43,000. RDBN paid \$34,458.20 against invoices for work done on RDBN jurisdictions (including REDRR) and an additional \$2,293.54 for the Landowner Rebate Program for a total of \$36,751.74 (not including GST). That leaves \$6,248.26 of unspent RDBN funds. Depending on the season, what new sites are found, treatments, and so on, the total amount invoiced may vary.

The following details why the total amount for 2015 was not used:

- it is difficult to predict the extent of work required (plants and seasons do not always cooperate!) and NWIPC does not encourage contractors to "look for work" to maximize a budget; we want the money to be well spent
- the portion of RDBN funds allocated by NWIPC for the Buck Flats field scabious project is a challenge due to the size of the infestation, which is predominantly on private land; NWIPC contractors have challenges with the landowners not wanting chemical treatment, yet the scope of the infestation is too large for effective, long-lasting mechanical treatment

- the Regional Early Detection and Rapid Response program (REDRR) money is spent where and when needed; you can't predict or arbitrarily choose what is an REDRR site so the amount required is an estimate and not a predictor of how much will be spent; there are regionally specific species identified as qualifying for REDRR;
 - o see <u>BC Invasive Species EDRR Plan</u> for details about what qualifies as an EDRR species
- NWIPC Landowner Rebate (50/50) is spent only as NWIPC receives applications from private landowners; the amounts refunded, based on applications from landowners, did not add up to the total allotted in the RDBN IPM budget

- There is a large focus on improving recreational access in the Bulkley Valley region. Many agencies, community's and organizations realize the opportunity and necessity to support inclusive activities, both as an economic driver as well as to reinforce the Provinces' "2024-Access and Inclusion" portfolio.

- Numerous sites in Regional District Area A and other BNRD Areas are identified for their potential to provide improved access through initiatives like the Bulkley River Access Project and community tourism development portfolios.

They are in areas close to Houston in the Morice River drainage, close to Telkwa on the Telkwa River, in the Babine and Hudson Bay Mountain areas close to Smithers, and on the west side of Smithers east of Moricetown.

- This access audit proposes to conduct an inventory review of identified recreation sites and trails in the defined area, assessing areas using a universal access - disability lens.

- This is a subsequent project to compliment the Lakes Outdoor Recreation Society's

(LORS) access audit conducted in 2013 that involved 12 site reviews in the BNRD areas in proximity to Burns Lake including; Kaegar Lake, Takysie Lake, numerous sites around Francoise Lake, Petersons' Beach on Fraser Lake, BC Parks Pendelton Bay on Babine Lake, Twin Falls in Smithers area, and;

BC Parks Highway 16/Highway 37/Naikoon Prov. Park - Haida Gwaii site reviews conducted in 2011, 2012 and 2013 assessing 21 Park areas in the NorthWest including; Tyhee Lake, Driftwood Canyon, Beumont Provincial Park, Ross Lake, Sealy Lake, Nisga'a Memorial Lava Beds, Lakelse, Mount Robson, and others.

- The assessments pictorially and graphically reflect how the existing recreational areas currently are, and provide recommendations for improvement – either with Basic, Intermediate or Universal Access. This information is compiled into a document that then is used by community, government agencies, non-profits, etc. to assist in decisions, planning, and budget designations that work towards implementing the recommendations and improving the regions' accessible outdoor recreational features and opportunities.

3. Describe how this proposal will benefit the community.

- There is an ever-increasing population of consumers with disabling conditions, seniors, families, health care providers, tourism operations, education centres, First Nations community's, American travellers, international elder hostels and others who are venturing into our community and regional district areas in northern BC.

- Many require adapted and accessible accommodations and experiences to meet their physical, psychological, emotional, health, and financial restrictions. Often they seek respite and adventure in our natural areas.

- Due to physical limitations of mobility, strength, endurance, and the need to feel secure and safe, they gravitate to areas that provide accessible amenities like camping, outhouses/bathing facilities, picnic areas/fire pits, adjoining trails/pathways/resting areas, fishing docks/boat launches, outdoor amphitheatres, viewing platforms, definitive interpretive panels and features.

- People with impairments and seniors want to travel and recreate with their families and do not want to be left behind because they can't interact or join in the experiences that are happening.

- When the Park areas, sites and trails in and around our communities are able to accommodate people with a proper standard of human dignity, even perhaps when in more remote off-the-beaten path areas, then equality is realized for all and everyone is included in the healthy adventure and experience.

- Great value and a heightened awareness has been realized by those in places of decisions who are working with the recommendations from the previous access audits and implementing the upgrades and improvements to accommodate persons with disabling conditions and seniors. Their understanding of the dimensions of access are greatly increased through realizing the various components that entail Basic, Intermediate and Universal Access and this knowledge is shared with co-workers and allies in their sectorial community.

- Economic benefits are realized in the service communities (towns) when an increase of consumers comes to an area because of the accessible experiences. Grocery



stores, retail outlets, cultural venues, and all aspects that entice and encourage people to venture into the community reflect these consumers. This is integration and inclusion.

- References can be provided by those from BC Parks, Ministry of Forests – Forest Recreation Sites and Trails, LORS, Tourism and other organizations to substantiate the value of the audits as working tools for all involved in implementation and serving the public.

The District of Vanderhoof in partnership with School District No. 91 (Nechako Lakes) is interested in conducting a feasibility study to determine the viability of building a production greenhouse at Nechako Valley Secondary School. The greenhouse would be open to community and student use. It would involve year round production, which would provide an avenue for education, revenue generation and research. Options for green energy will be explored in the design concept. The greenhouse would provide a "living classroom" which would support project-based learning and dual credit options for students and adults from across the District; thereby, addressing the critical succession and recruitment challenge faced in this industry. This project also has the potential to link with, and enhance, the many vibrant on-the-ground farming initiatives and research in the region. The feasibility study is the critical first step to this multiphase project. It will provide critical information required to secure funding for infrastructure development phase; ensure future dollars are invested wisely; and, garner the greatest outcome for the community.

3. Describe how this proposal will benefit the community.

Agriculture is a significant contributor to the economic fabric and diversity of the region. Local knowledge, the Bulkley-Valley Regional Skills Gap Analysis, and current BC Labour Market statistics, all identify jobs in Agriculture as the top upcoming occupational demand for the region; ahead of mining and forestry. As concerns for food security increase, opportunities to support the availability of local food, as well as maintain and improve the economic viability and profitability of agriculture, remain a significant goal for the community and region. All these factors together suggest that investment in the proposed project is timely.

There are many potential benefits to this project.

• In Stage One there will be individuals hired to conduct the feasibility study and community groups working together to learn about the viability of production greenhouse development. The knowledge gained from this study will inform the next phase of the project, as well as

provide the local agriculture community information as to potential design recommendations and crop outcomes of production greenhouses in this region.

- In Stage Two, there will be a variety of jobs created during infrastructure development. Where possible, this will include work experience for high school students. Again there will be the benefits of increased community capacity as individuals learn more about how to efficiently and effectively design and build production greenhouses for a northern climate.
- In Stage Three, the 'living classroom' will provide countless opportunities for students to explore a career in agriculture; experience project-based learning in a variety of subject areas; and, perhaps even link to dual-credit opportunities with a post-secondary partner. By having students run the greenhouse, learn from the local farming community, and become engaged in local research, this project has the potential to enhance the economic viability and profitability of agriculture. In addition, it may increase the amount and diversity of agricultural products produced in the region. Furthermore, there will be significant opportunity for broader community involvement in research and education.

This project meets several of the identified goals established in the 2012 Regional District of Bulkley Nechako Agriculture Plan including:

- 1. Diversify and strengthen the agriculture sector
- 2. Form stronger partnerships across the agriculture sector
- 3. Increase capacity to train and recruit the required workforce


