REPORT

Reinstate Cardboard Ban at Knockholt Landfill

The following was discussed:

- Option to burn cardboard with wood waste
 - A number of conditions and considerations a concern
- Timeline to reinstate ban
- Temporary solution impacting potential future commitments from Recycle BC and its post-collection company Green for Life (GFL)
- Green for Life willingness to provide compensation for residential recycling receiving facility and not ICI
- RDBN staff spoke with GFL and they indicated they will visit the region in August, 2020
- Temporary solution to address ICI cardboard only
- Option for secondary uses for cardboard e.g. pellets
- Investigating implementing a region wide plan to equalize cardboard recycling across the region
- Important to remove cardboard from the landfills
- Establishing a working group
 - Proactive role
 - o Interested businesses to utilize cardboard for secondary purposes
 - Reaching out to schools
 - Small scale recycling within the RDBN
 - Support business recycling initiatives
 - Economic development opportunity
- Fuel surcharge to transport cardboard from Smithers to Knockholt Landfill
- High expense for companies to transport loose cardboard
- Transporting cardboard to Prince George nearest receiving facility with capacity
- Reinstating cardboard ban at Knockholt Landfill
- Impact to phase development of Knockholt Landfill due to the temporary lifting of the cardboard ban
- Net zero solution/options for cardboard recycling.

Subject: Solid Waste Inventory and Feasibility Plan

RECOMMENDATION:

BACKGROUND INFORMATION:

The cardboard receiving facility in Smithers in May 2019 was lost to fire, which resulted in the temporary suspension of the curbside recycling program in Smithers and Telkwa and the inability to recycle Industrial, Commercial and Institutional (ICI) waste locally. As a temporary solution, additional staff was added to RDBN's Smithers/Telkwa Depot which was subsidized by Recycle BC (RBC), and the cardboard ban at the Knockholt Landfill (KLF) was temporarily lifted. During the past year, RBC was going through a transition to a new post-collection provider which has delayed the re-establishment of the curbside program. In addition, besides numerous meetings with the Ministry of Environment, no progress has been made on an ICI solution in rural British Columbia.

On May 21, 2020, the Board approved the recommendation to reinstate the cardboard ban at the KLF effective August 1, 2020. The volumes of cardboard over the past year received at KFL has impacted the integrity of landfill has resulted in moving up future capital costs for cell development. The RDBN recognizes the impacts of this decision and will be endeavouring to lead and assist in alternative solutions for ICI cardboard. The following outlines steps and initiatives to be undertaken.

STAKEHOLDER ENGAGEMENT PLAN (tentative dates):

May 27, 2020: Hire Tetratech to conduct the waste inventory study for the RDBN. The RDBN has an on-going relationship with Tetratech, and they are very familiar with our regions waste management program. The Ministry of Environment was also provided with an update regarding our continued cardboard issues and the decision to reinstate the ban.

May 28, 2020:	Inform all waste/recycling haulers in the western portion of RDBN (Burns
	Lake and west) of the effective date for reinstating the cardboard ban at
	KLF. Set up a stakeholder meeting to discuss potential solutions or
	partnerships (June 10 th ?).

- May 29, 2020: Issue a press release informing the public and businesses about the cardboard ban including some background on the issues with ICI and inviting the business community to propose/offer solutions.
- June 1, 2020: Begin planning and logistical preparations for a temporary ICI cardboard receiving/handling solution in the Smithers area.
- June 10, 2020: Meet with waste haulers to discuss their potential role in finding a solution
- July 3, 2020: Receive Tetratech's Feedstock Inventory Report
- July 6, 2020: Meet with Stakeholders to present the Feedstock Inventory Report and discuss potential solutions
- July 7, 2020: If no immediate solution for receiving/handling of ICI cardboard is solidified by private enterprise at the June 30th meeting, the RDBN will look at moving forward with establishing the necessary infrastructure for a temporary solution, and present the plan and options at the July 16th Board Meeting.
- August 1, 2020: RDBN receiving/handling temporary solution operational (if necessary).
