BC Air Access Program Survey for Ministry of Transportation and Infrastructure

The Ministry of Transportation and Infrastructure is conducting a survey to improve the BC Air Access Program (or BCAAP). The BCAAP is a provincial cost-sharing program that supports the connection of communities and helps build BC's aviation sector's long-term potential. BCAAP assists with funding capital infrastructure projects that help maintain safe and reliable aviation facilities, or that result in significant economic benefit.

BCAAP was introduced in 2015 with a three year \$24M commitment providing capital funding to airport development projects in support of safety, medevac, community economic development and general access. BCAAP projects have improved 44 airports with a geographic distribution throughout the province.

Virtually any aviation capital infrastructure is currently eligible, including:

- → Airside (i.e., runway, taxiway, apron enhancements; airfield lighting; fuelling facilities; navigational aids; helipads)
- → Terminal building upgrades
- → Groundside facilities (i.e., vehicle parking areas; security gates; flight path obstruction clearing; emergency access roads)
- → Other aviation infrastructure not on an airport (i.e. hazard beacons marking terrain around airports; facilities serving float plane traffic)

The BCAAP contributed \$552,046 towards the completion of the Baker Airport Rehabilitation Project.



Cannabis regulation committee underway

Victoria - A joint provincial-local government committee that will consider policies related to cannabis legalization and regulation in British Columbia is set to begin meeting later this week.

Minister of Public Safety and Solicitor General Mike Farnworth announced the creation of the Joint Provincial-Local Government Committee on Cannabis Regulation (JCCR) at the Union of B.C. Municipalities (UBCM) convention in September. The purpose of the committee is to provide a forum for communication and consultation so that the Province considers local government input during the development of the regulatory framework for legalized non-medical cannabis.

"It goes without saying that local government will be on the frontline and instrumental in the delivery of new policies and laws associated with the legalization of non-medical cannabis in British Columbia," Farnworth said. "We welcome and value the Union of B.C. Municipalities' input as we build a framework for the province focused on protecting young people, health and safety, keeping the criminal element out of cannabis and keeping our roads safe."

UBCM has appointed 12 representatives to the JCCR drawn from elected officials, staff specializing in planning, building inspection, bylaw enforcement or public safety, and senior staff. Provincial representatives are provided through the Ministry of Public Safety and Solicitor General. The first meeting of the JCCR will take place on Friday, Oct. 20.

"Local governments welcome the opportunity to work with the Province as it develops a framework for cannabis legalization in B.C.," said Wendy Booth, president, Union of B.C. Municipalities. "There are a lot of details to be considered in a short period of time. We want to ensure that the resulting policies are practical and workable for communities in British Columbia, and leave room for local decision-making."

Re: Coastal GasLink Route Amendment

- South of Houston / North of Colleymount Road.

BACKGROUND

The Coastal Gaslink Pipeline Project involves the construction and operation of an approximately 650 km long natural gas pipeline from near Dawson Creek to Kitimat, BC. The Environmental Assessment Certificate for the Coastal Gaslink Pipeline project was issued in October of 2014.

The RDBN has been advised that Coastal GasLink (CGL) anticipates filing an application with the Provincial Environmental Assessment Office (EAO) in a few weeks to amend their certificate for the project. The proposed amendment involves relocation of a 42 km section of the pipeline to a location approximately 4 km to the south. The route amendment is in Electoral Area E southeast of Houston and north of Colleymount Road, as shown on the attached maps.

At this time CGL and the EAO are not asking the RDBN for feedback on the proposed route change. The formal application will be made by CGL to the EAO in early November. The RDBN, as a member of the EAO Working Group charged with assisting in the project review, will be provided with additional information in support of the application.

THE REVIEW PROCESS

Once the amendment application review process begins the following process can be expected to occur.

- 1. The RDBN will be provided with information on the application and given approximately three weeks to provide feedback to the EAO.
- 2. The EAO will ask CGL to work with the RDBN to clarify and resolve any RDBN issues.
- CGL will document any RDBN concerns and the steps they propose to address the RDBN concerns in a tracking table.
- 4. The RDBN will be provided an opportunity to comment on the manner in which CGL has addressed any RDBN issues.
- 5. The EAO will consider the working group feedback and refer the application to the Minister for a decision.

Further details on the timelines associated with the above process will be provided once the application review process begins.

PRELIMINARY REVIEW

Given the limited timeline for the RDBN to review and comment on the proposed route amendment staff are providing the Board with the opportunity to identify any potential concerns they may have. Staff can raise these concerns with CGL so that they are prepared to address them during the application review process. Staff will then participate in the application review process as a working group member and report back to the Board with recommendations.







Comments	The Committee was divided. There was much discussion. Although we agreed it may not be farmable / usable land, we did not want to set a precedent for removing land that is accessible (by road) from the ALR. Concerns moving forward of impact on infrastructure if subdivided and a new residence were to be established.

Comments:	Referring to APC comments from the May meeting minutes:-
	"The APC wants to support the applicants and their intention but has some concerns about another subdivision application (from the current owners, or another if the property is sold) for a third lot, divided by the road, in the future.
	The APC believes that if the applicants had discussed their intent with someone from the planning department at RDBN prior to making this application that their request may have been altered and may have only required a variance to achieve their goal.
	The APC believes that we may agree to an application to subdivide, if the application were for a variance to consider the approximately 12ac parcel between the road and the river and the remaining approximately 75 ac as per the division made by the existing road."

Thank you for the opportunity to provide comment on this ALR exclusion application.

I have not attended the proposed subject parcel for exclusion in person for a field inspection. In lieu of a physical site visit, information supplied from your comprehensive referral, which includes information submitted from the agent, is helpful. I recommend this application for exclusion be forwarded to the Agriculture Land Commission and North Panel for their review ideally with a site visit.

It is not within my mandate to provide comment on the possibility and/or options of future road access to the subject parcel, similar to not debating a potential economic benefit to the landowner as a result of selling and perhaps creating a fishing lodge on the subject parcel with no legal road access. I do have concern with the statement in the application that essentially states that the subject parcel cannot be used for agriculture so converting it to a recreational use will result in "no detriment to the ALR" because recreational riverfront properties are valuable and in high demand. Excluding the parcel out of the ALR would result in a net loss to the agriculture landbase would it not? With a CLI Soil Capability Rating of Class 4x, the subject parcel (soil capability) is representative of productive cultivated fields nearby.

Our Ministry Strengthening Farming staff consistently advise that increased non-farm use(s) in traditionally primary agriculture use area(s) can create landowner conflict. As stated in the application, the Bulkley River passes through the parent parcel, and combined with the CN Rail right of way, has "landlocked" the subject parcel from legal road access but also states this situation is very common across the Province. I would not want to see any precedent set for basis of ALR exclusion of arable land because of no (current) legal road access.

Maybe you would consider sending this referral to the FLNRO Regional Fisheries Biologist in Smithers for comment also?

- Ministry staff recognize the unique conditions of this application proposal. If the application is approved as per Agricultural Land Commission (ALC) Act Section 10, the subdivision approving officer is responsible for several actions as stated in ALC Act Section 11. See ALC Policy P-01 ALR Subdivision Approval by Approving Officers:
 http://www.alc.gov.bc.ca/assets/alc/assets/legislation-and-regulation/policies/alc policy p-01 alr subdivision approval by approving officers.pdf
- While this application appears to propose a subdivision that 'establishes a legal boundary along the boundary of an ALR' (ALC Act section 10 (1)(d)), any subdivision and lot line adjustment should in no way be construed as support for any future non-farm use or subdivision on the resulting parcel within the Agricultural Land Reserve (ALR). The resulting parcel remaining in the ALR is expected to continue to be subject to all pertinent regulations and policies.
- As stated in the Ministry's Guide for Bylaw Development in Farming Areas (Bylaw Guide), "Minimum lot size provisions for land in the ALR will vary by region. Subdivision should be considered only where it will enhance farming opportunities." And, "There are many instances where [ALR] land has been divided into smaller parcels than is helpful for agriculture in most regions of the province. Since small parcels sizes may limit the range of agricultural uses, it is recommended that local government establish the largest possible lot size for land in the ALR. This will provide for a wider range of farming opportunities and discourage expectations of subdivision in the future."

I am writing this letter in regards to the application of variance for the subject property at Lot 1, Section 15 and 22, Township 4, Range 5, Coast District, Plan PRP47996, located at 6120 Telkwa High Road. The owners of the 24.77ha property would like it to be subdivided into a 7ha (>17acres) lot with a 17.77ha remainder. The 7ha property will remain in that Agricultural zoning.

For the purposes of this application, only the smaller 7ha lot is being assessed.

SEWAGE:

During the subdivision process, the Approving Officer may refer this file to Northern Health for comment if deemed necessary. Usually, applications where the proposed lot sizes exceed 10acres, are not referred to Northern Health because there is likely some area on the property that will be adequate for sewage disposal. For this reason, no evaluation for soil suitability has been conducted. In some circumstances, proposed lots greater than 10acres will be referred to Northern Health if the property has unique challenges; for example, in the floodplain, significant water bodies on the property, substantially bedrock ...etc. The owner reported that a "rocky hill...covers much of [the proposed Lot 1]". The RDBN may wish to require the applicant to find a suitable sewage disposal area, if there is uncertainty that a suitable sewage disposal area is available.

DRINKING WATER:

For this proposal, Northern Health will not require the applicant to prove availability of potable water. However, pursuant to the *Drinking Water Protection Act* [SBC 2001 c.9] and *Regulation* [BC Reg 200/2003], the owner/operator of a water supply system must obtain an operating permit and comply with regulatory requirements. A water supply system is a domestic water system (i.e. Used for drinking water and other domestic purposes) that serves more than one single-family residence.

I have no objections with this proposal.
