Results and Next Steps

On June 24, 2014 the Regional District of Bulkley-Nechako received the completed 'GIS Study to Identify Potential Burial Sites' that are expected to meet the Ministry of Agriculture Protocol #1, a diagram of which is attached for your reference. Below is a summary of the results of the study.

Results

The individual soil associations for the Soils of BC coverage were classed into the three suitability ratings. Ten were found to be most likely suitable, and fourteen were found to be possibly suitable. These are listed in Table 5.

The results of the classification (including both the Soils of BC and Surficial Geology layers) are given in Table 6. An overview map of the results of the study is attached. The most suitable areas were found to be glaciolacustrine deposits, and morainal material with a high proportion of fines; these are generally found on valley bottoms and mid-slope positions. Higher elevation sites were generally found to have much coarser and more rapidly-draining surficial materials.

NEXT STEPS

The RDBN has now completed the first three phases. Preparing a Plan. Exercising the Plan, and a 'GIS Study to Identify Potential Burial Sites', of a potential six phases of the Farmed Animal Mass Carcass Emergency Disposal Planning Process.

During the RDBN FAMCDEP Exercise Recommendations 3 and 4 were identified due to concerns with disposal in the event of a mass carcass event where the animals are unable to be buried or composted on the Farm of Origin. This may occur in many circumstances including but not limited to the following:

- wildfire event where livestock on range expire:
- cattle liner accident:
- > flooding event where livestock have been pulled downstream and washed up off the farm of origin:
- the farm of origin does not meet the following criteria for burial or composting purposes:


To address these potential issues Investment Agriculture Foundation of BC (IAFBC) is prepared to fund the Regional District of Bulkley-Nechako for the cash costs of hiring consultants and/or contractors to carry out the action items for the following phase:

Phase 4: Short List Suitable Sites for Further Investigation

Objective:

To develop a short list of suitable sites for drilling investigation for each of the subareas of the study, that could serve each of the areas as follows:

- Electoral Area 'E', François/Ootsa Lake Rural on the south side of François Lake;





BC Emergency Animal Carcass Burial Site Identification Project Proposal for Preparation of Short List of Potential Sites for Drilling Investigation

This proposal is presented by Victor R Klassen, P.Eng. of VRK Consulting Inc., in cooperation with John C Oosterveen, P.Eng. of ProFessional Resource Assessment Ltd (PFRA) to prepare a ranked short list of potential sites in each targeted sub-area of each Regional District (RD) in BC wanting to have a short list of potential sites for emergency carcass burial as described in BC Ministry of Agriculture and Lands (MAL) Protocol #1. This list could be used to select the top ranked potential sites for drilling investigations which, if confirmed to be suitable based on the investigations, could be certified for emergency carcass burial and thus be available in perpetuity for the intended purpose.

Victor R Klassen, P.Eng. has worked extensively finding emergency carcass burial sites in the 4 western provinces while employed with Agriculture and Agri-Food Canada (AAFC) as a geotechnical engineer including the pilot project for BC in Peace River conducting geotechnical investigations. He was subsequently contracted as a consultant to coordinate the Geographical Information System (GIS) studies conducted in BC for emergency carcass burial site identification. Victor currently resides in Qualicum Beach and is a registered professional engineer in BC.

John C Oosterveen has worked extensively in the 4 western provinces as an engineering geologist while working for AAFC including developing extensive expertise in conducting and interpreting Electro-Magnetic (EM)31 non-intrusive geophysical surveys. John also worked on the pilot project in Peace River conducting EM31 surveys and geological assessments. John now operates as a consultant and currently resides in Winnipeg. John is eligible for registration as a professional engineer in BC.

Cost estimates are being prepared including potential work by third parties for submission if the proposed process is approved.

Background processes:

- VRK to consult with RD representatives to review the planning maps prepared during the GIS study and confirm the locations and number of sub-areas in the regional district where emergency carcass burial sites are required as discussed at the presentation of results of the GIS study.
- Establish communication with RD GIS specialist and review process for identifying potential sites for detailed review based on the GIS mapping resultant polygon layer of



green (likely suitable) and yellow (possibly suitable) sites in each of the targeted subareas.

• It is expected that VRK will work closely with the RD GIS specialist during the preparation of the short list to ensure that the needs and wishes of the RD are addressed. This may require approximately 40 hours of time for the RD GIS specialist. Where possible, McElhanney Consulting (who conducted the initial GIS mapping) will be utilized to provide GIS mapping services to minimize the work required of the RD GIS specialist. It is proposed that VRK Consulting will contract McElhanney directly with no handling charges so that McElhanney will report directly to VRK Consulting. Other third party service providers will be handled in a similar manner. It is envisioned that the work will be carried out in 8 stages as follows:

Stage 1) Assessment of possibly suitable moraine sites (yellow) - McElhanney Consulting

McElhanney to provide a GIS map layer of morainal sites in yellow and green categories. McElhanney to indicate how many types of moraine are present in each category and provide details of each type. Include a table same as the table in the initial GIS study report for yellow and green moraine so that we can subtract the results of the proposed study from initial GIS study to see the difference in number of sites potentially made available if we were to investigate yellow morainal sites in more detail. Including the green morainal sites will give us an idea of the benefit of further investigation of yellow moraine sites if there are green moraine sites in the vicinity.

Note that revising the suitability criteria will not only benefit the selection of regional burial sites but will also enhance the possibility that on-farm burial will be suitable to minimize the use of landfills or regional burial sites.

Stage 2) Initial screening of sites defined in resultant polygon layer of green sites. Ensure that all landfill and waste transfer sites are included – McElhanney Consulting

McElhanney to update GIS mapping as per the following:

- Remove from the list all private deeded land and First Nations land.
- Compare list of compatible and non-compatible tenures to tenures identified in the
 initial GIS study mapping. (Checking with McElhanney to confirm that tenure types
 were included in their mapping). Remove from the list all sites with non-compatible
 tenures. Examples of non-compatible tenures are community recreation areas such as
 ballparks and campgrounds.



- Remove from the list all polygons or portions of polygons where torrent flows are identified as obtained from the MoE website.
- Update mapping of access roads to include all public and private roads such as logging and mining roads as available from the MoE website and mark as private or public. Remove from the list all sites where access is greater than 1 km from the site.
- Show water well locations on map including 300m buffer and also watercourses including 100m buffer.
- Produce revised resultant polygon layer map with remaining sites shown with a green boundary around perimeter of site showing orthophoto within the green site boundary.

Stage 3) Evaluate initial screening of mapping results with preliminary table of rating and ranking. Rating criteria out of maximum 3 are proposed – Vic Klassen

- Access adjacent to public road (3) access adjacent to private road (2) access up to 1 km away (1)
- Orthophoto review unobstructed and suitable landuse (3) slightly difficult to survey or drill, or marginally unsuitable landuse (2) difficult to survey or drill, or possibly unsuitable landuse (1)
- GW well data (review prelim from MoE website) no wells in vicinity or deep (3) wells adjacent but deep (2) wells adjacent shallow but likely acceptable
- Proximity to watercourse far away (3), somewhat far away (2) close proximity but likely acceptable (1)
- Rank sites based on the above. Conference call review of results with RD staff, Rick, MAL and VRK to assess if sufficient sites to proceed to Stage 4. If not, assess whether an investigative assessment of moraine might provide additional green sites in which case a funding amendment would be required plus additional time or repeat Stages 2 and 3 with yellow possibly suitable sites.
- Identify which sites to go Stage 4

Stage 4) Geological information on list of sites from Stage 3 – John Oosterveen

• Surficial geology is available from initial GIS mapping either referencing embedded mapping information details as provided by Westrek Geotechnical. Obtainable from McElhanney if not directly from GIS mapping



- John Oosterveen to prepare geological assessment of potential sites to assess suitability of each site based on Protocol #1 criteria
 - Obtain surficial geology as per previous bullet
 - Obtain sub-surface geological information from MoE website
 - Obtain water well data from MoE website
- · Rate Initial ranking of sites to pick best 10 in each sub-area.
- If existing waste transfer or abandoned landfill sites are still on list, check RD for existing subsurface information such as testhole logs or groundwater levels.
- If insufficient number of sites, could go back to McElhanney and regenerate mapping using 10% slope instead of 5% as speculative approach (optional).
- Rate and rank sites picking best 10 (max) in each sub-area for site inspection.

Stage 5) Inspection - Vic Klassen and John Oosterveen

- PFRA to mobilize by vehicle from Winnipeg with EM31 and related GPS equipment to pick up Victor at regional airport and together inspect best 10 (max) sites in each subarea checking out road cuts, Dutch auger holes, site difficulties, public separation to avoid direct viewing of potential burials, etc.
- Rate and rank sites to pick best 6 (max) in each sub-area for EM31 surveys by John Oosterveen assisted by Vic Klassen. The EM surveys/site inspections are best conducted together (VRK and PFRA) for safety and efficiency.

Stage 6) EM survey – John Oosterveen and Vic Klassen

- Conduct EM31 surveys on best 6 (max) sites in each sub-area plus any sites where moraine investigations were conducted for reference.
- · Compile EM surveys and interpret, update geological assessments, and re-rank.

Stage 7) Presentation to stakeholders - Vic Klassen

- Presentation to stakeholders including RD board and staff, Cattlemen's Associations and/or First Nations for feedback.
- · Re-rank based on feedback from stakeholders.



Stage 8) Reporting of results

- VRK to report to RD and MAL with all information obtained during the proposed study including the following:
 - Summary of initial GIS mapping results including the rationale for selection of the sub-areas chosen for the study, locations and numbers of sub-areas in the regional district where emergency carcass burial sites are required (background processes), and the ranking and re-ranking of sites in stage 7 to have a record of stakeholder feedback
 - Description of all stages of the proposed study and decisions made during the process
 - a ranked table of the sites referencing all related information including EM surveys
 - GIS mapping results





Pink lines enclose proposed areas of cultivation (2) leaving the area of the spring runoff (blue lines) with a buffer zone. We also plan to leave a treed area between the application land and the private land to the south. There will be a shelter-belt between the cultivation areas and the fences to help retain moisture and reduce weeds from blowing in to cultivations, with the exception of where the fence attaches to our private hayfield to the east.

We would like to leave the low areas in the southwest quarter below the road to filter any spring runoff. The land here in this low area is, in part arable, but some of the swells are swamp like and it would be a good area to leave alone.

The land is fenced on two sides; on East side the land is owned by us and is fenced, and on the South side the land is privately owned and also fenced. The land is unfenced on the West and North sides and we propose to do the fencing in the second year. The Northwest corner will be fenced in such a manner that will allow sufficient room for the cattle grazing to be able to access the Northeast quarter of section 30.


Propose to log merchantable timber in the first and second year after purchase in the areas to be cultivated. The logging is proposed to take place in the winter months to minimize disturbance. Mature timber would be logged so that the stumpage would be paid. Mature timber, if any, in wet areas would be tipped out of wet area so as to avoid entering these areas with equipment.


Once the logging is complete, stumping, piling and preparation to disc would be started. Within three to four years, we would like to have the proposed cultivation areas into grain production.



This application is for the purchase of Crown land which the applicants currently lease. The subject property (Lot 15, District Lot 1352, Range 5, Coast District, Plan 5380) is located at 48840 Mill Bay Rd, on the western shore of Babine Lake, south of the Village of Granisle. This subdivision was created to provide Crown recreational lease lots however, the majority of these lots are now privately owned. The majority of parcels in this area are developed.



The subject property is 0.13 ha in size and is R4 (Waterfront Residential II). The property is smaller than the 0.8 ha minimum parcel size required for subdivision in the R4 zone.

The property contains a dwelling which appears to be used by the property owner for recreational purposes. There is a building permit from 1975 on file, for the construction of a cottage.

In situations such as this, where the parcel is relatively small, achieving appropriate on-site sewage disposal may be challenging, and a more expensive Type 2 or 3 system, or a pump and haul system, may be required.
