Director Fisher requested further data in regard to ridership in respect to departure time for Houston to Smithers and Houston to Burns Lake Mr. Fudge will provide the information for a future Regional Transit Committee meeting. Discussion took place in regard to a future performance review being completed on an annual basis.

Director Newell spoke of the ridership in Whistler Mr. Fudge mentioned that there are some contributing factors such as the increase in tourism in the winter months, the layout of the community, etc. He also noted that local government has concentrated efforts on marketing transit to minimize vehicle use in and around Whistler.

Ms. Harmon mentioned that the Ministry of Transportation and Infrastructure has the Transit Minor Betterments Funding Program to assist in funding infrastructure needs moving forward. She has provided the information to staff.

Ms. Harmon commented that it has been a very rewarding process in the development of the Bulkley-Nechako Regional Transit and congratulated everyone that worked to make it a success.

Ms. Harmon provided a PowerPoint Presentation.

Ms. Harmon noted that the BC Bus North Program is a 12-month interim solution. She noted that feedback is required to understand the benefit to communities to have a long haul service and potential options to provide transportation to help to support the continuation of a service. Ms. Harmon mentioned that any suggestions or ideas can be forwarded to her.

Ms. Harmon noted that conversations have taken place between the Honourable Claire Trevena, Minister of Transportation and Infrastructure and the Honourable Marc Garneau, Minister of Transport Canada in regard to Greyhound providing notification that the company will be withdrawing service from western Canada.

Director Greenaway commented that Fort St. James and area has lacked bus service for a number of years and questioned the options to have bus service for the Fort St. James area. Ms. Harmon noted that consideration was given to have BC Bus North travel to Fort St. James but due to the size of the fleet it was unable to travel to Fort St. James. She noted that MoTI is aware of the need for service but a solution has not been found.

Director Beach noted that he has received very positive comments in regard to the Bulkley-Nechako Transit system.

Acting Chair Miller thanked Mr. Fudge and Ms. Harmon for attending the meeting.

# 2018 Rider's Survey Report

#### Background

At the September 7, 2017 Rural Directors Committee meeting discussion took place in regard to further information being provided in the Ridership Breakdown. It was noted that there is a need to know where riders reside that are using the Bulkley-Nechako Transit Service.

#### Introduction

In 2018 the rider's survey was conducted in March, July, and December on both routes of the Bulkley-Nechako Regional Transit System. The purpose of the survey is to learn more about where transit rider's primary residence is located. Additionally, four questions are asked to provide more information on transit riders, and a space for comments was included.

- 1. Why are you riding the bus?
- 2. How often do you ride the Bulkley-Nechako Transit System?
- 3. What best describes your transit travel?
- 4. What age category best describes you?

The following tables below summarize data collected throughout 2018 for both the 161 and 162 routes.

#### **Table 2: Comparison of Rural and Municipal Ridership**



- March had the highest number of riders that indicated they live in a rural area
- December had the highest number of riders that indicated they live in a municipality

**TABLE 3: Rural Ridership** 



- 54% of survey participants live in a rural area.
- All electoral areas were represented in the survey responses.



#### TABLE 4: Municipal Ridership

- 43% of survey participants live in a municipality.
- Granisle was the only municipality not represented in the survey data.

• Most rural and municipal participants are regular riders indicating 1-2 trips a month.

• The participants returning on the same day are approximately equal to the participants retuning on a future day.

Most rural and municipal riders are between 25-64 years of age.

- The main reason for travel among rural and municipal participants is to visit friends and family.
- December saw an increase in the number of participants using transit for shopping trips

#### Participate Suggestions

During the three months the survey was administered 80 suggestions were made. The following includes some of the suggestions that were made and a total number of suggestions that shared a common theme.

#### Wifi requests - 27

Awesome connection bus between this bus & City's (PG), safe & affordable for people traveling. There is a need to send messages sometimes and people have no minutes or just tablets. The bus needs Wifi for messenger calling or maps etc.. Thanks

#### Larger Bus – Prior to new buses – 6, After new busses – 5

Great bus driver, a larger bus would be nice as it is almost full. Keep up the great transit. (comment after new busses went into service)

#### More storage space – 5

No luggage room is a problem on a bus that travels so far.

#### Bus Pass request – 4

Would like to be able to purchase a bus pass, I use the bus everyday.

#### Seatbelt – 4

I like the new buses. Why no seat belts, I need them for child seats.

#### More bathroom stops - 2 (comments on installing a bathroom on the bus were omitted)

Needs more stops for washroom breaks

#### Increased frequency on 161 – 21

Need two buses a day both days between Vanderhoof and PG

Need bus everyday to PG because people travel everyday, and it is a ride you can afford

I am pleased to write that I always love to travel in this service. My request, can you please start on a daily basis and it would be nice if I could connect from the airport in Prince George.

#### Increased frequency on 162 – 4

Need the bus 5 days a week from Houston to Smithers to get to work.

Would like a weekend night bus to Smithers and more like Thursdays with trips home in the evening so I can watch movies or game in Smithers

#### Request for a bus to Fort St James (10)

Please consider a bus from Fort St James to Prince George

First time using the bus and it was awesome. I wish it went all the way to Fort St James



#### **Participant Comments**

During the three months the survey was administered 120 comments were made. It is worth noting that all comments received were positive. The following includes some of the comments and a summary of repeated themes.

#### **Commending Bus Drivers – 25**

Please keep up the awesome services. I like this bus its very useful. The bus drivers are very respected

The bus driver is amazing with great customer service skills.

Enjoyed the trip. Drivers are friendly

I really appreciate the courtesy, friendly service

#### Affordability – 12

I am impressed with the feasibility for low income families. This is the best ever to happen to us.

Riding for a cheap rate for travel is awesome for people

Well needed transport for shopping, medical. Excellent for low income and elderly who do not drive

#### Gratitude – 35

Nice service, thank you. I hope it continues because it is very much needed.

Love the service, I appreciate the service.

Really do appreciate this service. It's the best can go to my Doctor in Smithers no problem. Can go shopping Smithers at groceries, Shoppers, etc.

#### **General Comments – 48**

Great service very needed. BC Transit is doing a great job and service for the people in the north west. Thank you

This service is so needed. Our small town (FL) has very limited resources. This service provides a means of transportation for low income groups for health and wellness appointments among other things that rural towns do not provide

Please keep this bus running, it's a good way for folks with low income with no private transportation to get Vanderhoof, PG or Smithers for medical appointments. BC Transit has more convenient picking up points than other buses in the area, especially in the winter. Keep up the good work.

This service is awesome. I don't know what I would do without it.

I love taking the transit bus, it is so convenient. The best way to travel

### Conclusion

The data collected in 2018 primarily provides information on the primary residence of riders using the Bulkley-Nechako Regional Transit Service. Data collected on reason for travel, rider frequency, habits, and age demographic add value as it provides data on who the riders are. Comment and suggestion data are a definite bonus, providing feedback directly from the riders and giving us valuable insight into what shortfalls may exist within the system. One of the challenges that has developed is the decline in survey participation. A factor that may be contributing to the decline is that many riders use the service regularly and are not filling out the survey each time they ride. Continuing in 2019 may see a further drop in participation.

Lake Babine Nation has requested that a bus shelter be installed at the existing bus stop on Sus Avenue in the Community of Woyenne. There is a need to provide seating and shelter for passengers, a majority of whom are young mothers, people with disabilities, and elders. See attached letter of support from Chief Gordon Alec.

Budget costs for the Bus Shelter are as follows:

E Series Harsh Weather Shelter (Including Install)	23,000
Concrete Pad and Site Prep	<u>15, 000</u>
Total Budget	38,000

The BC Transit Shelter Program covers 80% of the cost of the shelter leaving the local government partner (Regional District of Bulkley-Nechako) responsible for the remaining 20% of the shelter cost and the site prep. The remaining costs will be applied for through the Ministry of Transportation and Infrastructure's Community Safety Enhancement fund. The application will be subject to approval. Lake Babine Nation is supportive of cost sharing should the application not receive full funding. Contingency funds in the budget for the Bulkley-Nechako Regional Transit service are available if required.

#### BC Transit continues to enhance safety with CCTV cameras

**Corporate** – In an effort to improve safety on board BC Transit buses, over 600 buses across the province now have closed circuit television (CCTV) cameras.

373 medium-duty and heavy duty buses have had cameras installed as part of a project supported by the Public Transit Infrastructure Fund (PTIF). The other over 230 buses with CCTV cameras are new buses delivered with the technology already installed. The remainder of the BC Transit fleet will have cameras installed in new buses as they are replaced over the coming years.

"The Government of Canada is proud to support these vital safety improvements to BC Transit buses across the province," said the Honourable François-Philippe Champagne, Minister of Infrastructure and Communities. "Having CCTV cameras on board will help reassure passengers that taking public transportation is a safe option no matter where you live."

In B.C., the PTIF represents a partnership between Canada, the Province and local governments to support investments in municipal transit systems. The CCTV installation is part of a series of technology enhancements on BC Transit buses worth approximately \$11 million. Other improvements will include Automated Passenger Counters (APCs), to provide a more accurate picture of ridership and allow planners to maximize resources; and NextRide real-time transit information, to help riders plan their trips efficiently.

The cameras have already proven themselves: since the pilot program started in 2015, BC Transit has used CCTV footage to support investigations almost 3,500 times. This includes over 360 police investigations.

"We place the highest priority on safety. The installation of CCTV cameras demonstrates our commitment to safety to our staff and customers," says BC Transit Chief Executive Officer and President Erinn Pinkerton. "Anything that can deter incidents or assist in investigations is a welcome enhancement for our service."

Over the past five years, BC Transit has made significant investments in both training and tools for its transit safety system, which includes: closed circuit television (CCTV) cameras, driver training to diffuse situations, partnerships with first responders, enhanced communication technology on board the bus and a proof of concept for a full driver door.





Each bus has four to eight cameras recording events in the interior. As well, a high-definition camera in the driver's compartment records events in front of the bus and two more cameras will watch the outside of the bus. Cameras are not monitored live, but video files are encrypted and stored on hard drives for up to seven days, required for investigation purposes.

Information is collected in accordance with the Freedom of Information and Protection of Privacy Act.

## All 12 community services running, benefiting people in the North

Prince Rupert - All 12 community transportation services are now operating successfully in northern B.C. communities along the Highway 16 corridor.

These services are helping thousands of people who live in small, remote and Indigenous communities travel safely around their communities and to neighbouring communities.

"This service is especially important for women and teenage girls, who have not had a safe way to get around," said Claire Trevena, Minister of Transportation and Infrastructure. "I am very happy to see that all of the community vehicles are now providing this vital transportation connection for remote and Indigenous communities in the North. This is a service these communities fought hard for, and now we can see the positive results."

These safe, reliable transportation services are providing more than 2,500 rides per month to people who live and work in the North. The services are run by the individual communities and are a key component of the British Columbia government's Highway 16 Transportation Action Plan.

"It's wonderful to see the community vehicle program is providing a safe ride home for so many people who live and work in northern B.C., in particular, for those in remote and Indigenous communities," said Jennifer Rice, MLA for North Coast. "This program is working in conjunction with the newly established transit routes by giving people safe, reliable and affordable transportation options."

"The Friendship House Association of Prince Rupert is proud to provide a transportation service between Prince Rupert and Terrace twice weekly, on Tuesdays and Thursdays," said Anna Zanella, executive director, Friendship House Association of Prince Rupert. "Feedback is positive as passengers enjoy the affordable service at \$5 per seat each way. The impact of this transportation project has been immense, as transportation opportunities out of Prince Rupert are very limited. Passengers can stay connected with adjoining communities in the region for employment, education, medical, extended travel and personal needs."

The B.C. government announced that 12 communities were receiving grants for the purchase of community vehicles and three years of operational support in spring 2017. These grants were primarily for Indigenous communities and organizations, enabling them to purchase and operate a community vehicle (such as a van, mini-van, SUV or bus) to transport people to jobs, school, appointments and shopping, as well as connecting them with family and friends.

"Takla Nation takes pride in the transportation service the bus is able to provide to our community and our neighbouring communities," said Chris French, Councillor, Takla First Nation. "This is a positive and reliable new transport service for people who live and work in our community. It's a comforting feeling knowing our people can travel safely."

The various recipients took the time necessary to fully develop their services prior to launching, with the final service launched in December 2018.

In Budget 2018, the Highway 16 Transportation Action Plan received a funding commitment for a fourth year, bringing the total investment to date to \$7.3 million.
