
We receive a wide range of people from all over the world as they are travelling to Alaska. The majority of people that

Pony Club members meet once a week in the winter to attend stable management classes, and twice a week in the spring and summer to participate in riding lessons and camps. In these classes, our members learn how to ride and jump as well as how to handle and care for horses. Students also have opportunities throughout the year to attend local and national competitions and to participate in testing.

Participation in classes and competitions provides students with unique opportunities to work independently as well as within a team to set specific goals and meet challenges. Membership in the club develops confidence, responsibility, sportsmanship, judgment and leadership. It also instills in young people a sense of pride and accomplishment in meeting attainable goals and standards. The specific training and opportunities that pony club offers young people in our community are unique and not available from other organizations in our community.

Members from our club come from Burns Lake as well as the surrounding communities of Francois Lake, Decker Lake and the Southside. Our club also works in partnership with other pony clubs throughout the region and hosts activities such as Pony Club Quiz, Pony Club Camp, National events, and an examiners clinic. These activities include riders from Quesnel to Terrace.

The club has a steady membership of 24-28 members per year. We have 20-30 volunteers.

Lakes District Pony Club is requesting funds to help our members with the cost of participation in the 2019 Pony Club Camp. As mentioned above, we are usually able to fundraise for this activity, but unexpected costs for new safety equipment has left the club short of necessary funds.

In Pony Club camp, members take two riding lessons a day and participate in riding games in the evening. At the end of camp, participants put on a riding show for parents. Throughout the weekend, they work as a team with older members helping younger members tack up and care for their horses. This is very much a cooperative event with club members across the region participating. Breakfast, lunch and snacks are provided, as well as prizes. This camp is the highlight of our year for members. We would like to keep the fees for this camp as low as possible for our members.

This year we will have 21 pony club members attending.

DESCRIBE HOW THIS PROPOSAL WILL BENEFIT THE COMMUNITY:

The Lakes District Pony Club is open to all members of the community and creates opportunities for children, as well as adults, of all ages and abilities to learn the important skills involved in caring for animals. Participation also helps to develop capacity for empathy and compassion. The lessons and educational components teach the participants not only how to work well with the animals, but also with each other. The opportunity for regular outdoor physical activity is also highly valued by participating families. With opportunity for older members to coach and assist younger members, self-confidence and important life skills such as leadership and effective communication are also developed. The Lakes District Pony Club is proud to help grow competencies of many kinds, and prepare members for future success in all areas of their lives.
