RECOMMENDATION (all/directors/majority)

1. "That the Rural Directors approve the 'draft' agenda for *Soil to Table – Celebrating Local Agriculture* October 23rd and 24th, 2020 in Burns Lake.

2. "That the Rural Directors approve the rotation of the Regional Agriculture Forum every other year from the Regional Business Forum."

BACKGROUND

Attached is the agenda for "Soil to Table – Celebrating Local Agriculture", the Regional Agriculture Forum 2020.

The 2020 event will have three "threads" running through the forum. The first "thread" will be celebrating local agriculture with a banquet featuring local food on the Friday evening and an "Armchair Tour" on Saturday morning featuring farms throughout the region that are in the RDBN Connecting Consumers & Producers directory.

The second "thread" will be healthy soil. Soil health is the continued capacity of soil to function as a vital living ecosystem that sustains plants, animals and humans. Regenerative agriculture and typical tilled soil field crop production with soil sampling and nutrients will be presented. Regenerative agriculture is a non-tilled soil that focuses on topsoil regeneration that increases the biodiversity, enriches soils, improves watersheds, enhancing ecosystem services, supporting bio sequestration (capturing carbon in the soil), increasing reliance to climate change and strengthening the health and vitality of farm soil.

The third "thread" will be tools for "Planning for Profit" for a full spectrum of agriculture producers from vegetable, honey bees, sheep, goat, etc. Currently Kwantlen Polytechnic University (KPU) has Enterprise Budgets for Southwest British Columbia. By introducing Enterprise Budgets could lead to future project to develop a Northern series of Enterprise Budgets. A copy of the Honey Bee Enterprise Budget is attached. The "Planning for Profit" will also be included with the keynote presentation. Presenter Joel Salatin has authored three books on farming for profit, "You Can Farm – The Entrepreneur's Guide to Start and Succeed in a Farming Enterprise", "Your Successful Farm Business – Productions, Profit, Pleasure" and "Pastured Poultry Profit\$ - Net \$25,000 in 6 months on 20 Acres". For more information about Joel Salatin, please visit his farm Polyface Farms website, www.polyfacefarms.com.

There will be an opportunity to showcase the RDBN Food and Agriculture Plan focusing on actionable items and there will also be a presentation on the draft of the 2020 project of Regional Food Hub & Agriculture Economic Study. Northern Development Initiative will give a short presentation of funding opportunities for agriculture. The Saturday

afternoon will have three sessions with the first two giving participants a choice and then bring the whole audience to the last session on soil health with a question period. All the speakers will be confirmed in January.

Invites will be sent to the Provincial and Federal Minister's of Agriculture as well as to BC MLA agriculture critic. Hopefully the Ministers will accept the invite and will be offered an opportunity to speak.

The venue will be determined in January. Saturday's event will have display tables and organizations sponsoring will receive free table. Other tables will be available for a small fee to cover table rentals if this is necessary.

The budget is still being finalized and a copy of the budget will be presented at the February 6th committee meeting with an updated budget for the April 2nd meeting. The month of January, staff will be securing funding.

The registration cost will be the following:

Full Registration (including banquet) \$100 Couple Full Registration \$150 Friday evening and Banquet \$40

The Keynote speaker, Joel Salatin will draw an audience from within and outside the region. Promotion and marketing of the event will start in January and the goal is to have at least 100 participants.

Southwest British Columbia Small-Scale Farm Enterprise Budget: Honey Bee

This enterprise budget presents costs and returns for a 50 hives small-scale farm in southwest British Columbia, Canada. The sample values are typical of small-scale hive production. These values were derived from data gathering sessions with representative farmers from the region, but do not represent any particular farm, and should be used only as a guide. The actual costs of production may vary from farm to farm depending on production method and scale, machinery use and other input costs. This budget is also available as a dynamic MS Excel spreadsheet to facilitate more detailed planning for your own operation. Please refer to the "Institute for Sustainable Food Systems Enterprise Budget User Guide for assistance in tailoring the spreadsheet to your own farm.

Assumptions:

- 1) The size of the bees is 50 hives
- 2) 15 extra hives are included as replacement
- 3) The interest rate is fixed at 5%
- 4) The annual fixed cost is estimated using the straight-line depreciation method.
- 5) Management time is not included as a cost. The net return over total cost may be considered as the return to management time.

SUBJECT: RDBN Food Hub and Food Economy Assessment

RECOMMENDATION (all/directors/majority)

1. "That the Rural Directors approve the RDBN Food Hub and Food Economy Assessment."

2. "That the Rural Directors approve staff to proceed with a Request for Proposal on BC Bid."

BACKGROUND

At the November 7th Rural Committee, \$100,000 was allocated to two projects that would be incorporated into the 2020 work plan for the Agricultural Coordinator. One project was the Food Hub Feasibility Study with an estimated cost of \$50,000 and the second project was the Non-Timber Forest Product Study for \$50,000. During this time, the RDBN applied for funding from the Victoria Foundation for the Regional Food Economy Assessment but was unsuccessful. During the application process for the Food Economy Assessment grant, it became evident that combining this project with the Food Hub project, and deferring the Non-Timber Forest Product Study, would provide better alignment and efficiency with other agricultural initiatives currently underway and planned for 2020. Therefore, the RDBN Food Hub Feasibility Study and the Regional Food Economy Assessment are two projects that could be run under one project: the "RDBN Food Hub and Food Economy Assessment". The project would utilize the \$100,000 of the Northern Capital and Planning Grant located in the Agriculture Planning Reserve.

A Request for Proposals (RFP) would be placed on BC Bid January 10, 2020 with a closing date of January 31st. Selection of contractor by a panel would be completed by February 14th. The project timeline will be February 20th to November 30th, 2020. The allocation for the contractor would be a maximum of \$70,000 for an approved workplan and the details will be listed in the RFP. The remaining \$30,000 will be workshops, surveys, final printing, etc. The project will have actionable items and there is a potential to acquire further funding from Agriculture and Agri-Food Canada "Project to Strengthen Local Food Systems". This funding could potentially fund a Pilot Project(s) in 2021.

What is a Food Hub? Food hubs are a crucial, but often invisible, part of the local food system. They help small farms grow by offering a combination of production, distribution and marketing services. Food hubs can be thought of as helpful middlemen that connect producers (farmers and ranchers) with institutional buyers (restaurants, hospitals, etc.) and increases accessibility of local food to consumers. Food hubs benefit consumers and the general public by creating jobs and increasing access to fresh healthy foods.


The attached diagram illustrates food hub and the data is from the US.

What is a food economy assessment? The RDBN will build a food economy assessment on a 2010 study in Ohio, https://community-wealth.org/content/25-shift-benefits-food-localization-northeast-ohio-and-how-realize-them. The

RDBN food economy assessment proposed to holistically study the cultural, environmental and economic value of the regional economy and what impacts could come for a 5%, 10% and 25% shift to regional consumption of regional foods. Outcome of the study will quantify and qualify the impacts of a projected shift to local food and evaluate increases in the number of jobs, level of regional economic output and growth in the tax base in the region. Cultural and environmental value will also be considered as part of this assessment.

The RDBN Food Hub and Food Economy Assessment will engage mainstream agriculture, emerging agriculture and indigenous communities in quantifying and qualifying the current economic, cultural, and environmental value of the regional food economy. Will project the cultural and economic value with a 5%, 10% and 25% shift to regional food being consumed regionally and integrate strategies from the Food Hub portion to develop new strategies for making the shift.

The BC Ministry of Agriculture has been promoting and funding Food Hub Feasibility Studies. The RDBN Food Hub and Food Economy Assessment would be unique as to date, this type of assessment has not been conducted in any region in BC.



EXECUTIVE SUMMARY

The Regional District currently has Service Areas that fund 'Road Rescue Services' through the Topley Volunteer Fire Department, Fraser Lake Fire Department, and Fort St. James Fire Department. Electoral Area 'A' has an 'Emergency Response' service that provides funding to Smithers Fire Department and Telkwa Fire Department.

In 2017 EMBC conducted a review of the RDBN's fire service bylaws and service agreements. EMBC informed the RDBN that task numbers, which provide funding for 'Extrication Services', would no longer be issued to any Fire Department in the RDBN that had a Road Rescue Bylaw, which created a negative financial impact.

Staff recommends the Rural Directors Committee provides financial support through the Emergency Preparedness Planning Service to the Fire Departments to support the continuation of this valuable service.

BACKGROUND:

Emergency Management British Columbia (EMBC) currently issues task numbers and reimbursement at a rate of \$330.00/hour for Fire Departments that provide "out of jurisdiction response" for road rescue services. An "out of jurisdictional response" is defined as:

"The service is outside the established Municipal and/or fire protection area and is not covered under a contract, mutual aid agreement, automatic aid agreement, or extended service bylaw."

Road rescue is not a responsibility of local government. The intent of creating road rescue related bylaws was to assist Fire Departments in their efforts to support the RCMP and BC Ambulance Service, not to take responsibility for road rescue. The amount of money raised through taxation is not adequate to cover the cost associated with providing the service.

The RDBN, as a good will gesture, agreed to assist local Fire Departments by making limited financial contributions to help support their road rescue efforts. Unfortunately, this has resulted in the Province eliminating their support for local Fire Departments providing this service.

In 2018 the Board directed staff to submit a resolution to UBCM regarding the governance and funding of road rescue services in the Province. This issue was discussed at the UBCM convention in September 2018 with M.L.A Jennifer Rice who is the Parliamentary Secretary for Emergency Preparedness. Through correspondence Ms. Rice has stated that she appreciated our concerns and challenges, and that they are currently working with the Fire Chiefs Association of British Columbia to develop a sustainable funding and governance model for road rescue.

Staff anticipates that the Fire Chief's Association will recommend to the Province that minimum training standards be developed for road rescue, and that the reimbursement at a rate of \$330.00/hour should be notably increased.

DISCUSSION:

RDBN Road Rescue Bylaws

The continuation of the Road Rescue Bylaws has a negative financial impact on Topley, Fort St. James, and Fraser Lake Fire Departments. Electoral Area 'A' Emergency Response Contribution Local Service Amendment Bylaw No. 853, 1995 does not affect Smithers and Telkwa Fire Departments from billing EMBC for 'Extrication Services'.

By repealing the 'Road Rescue Service' bylaws the Topley, Fraser Lake and Fort St. James Fire Departments will once again be eligible for funding from EMBC on 'Road Rescue' responses. The cost of the training and equipment to provide emergency services is substantial and ongoing. Some of the major expenses are:

Granisle Fire Department only provides emergency services within the municipal boundaries, Southside and Fort. Fraser provide services within their fire protection area only, and Cluculz Lake Fire Department does not provide Road Rescue services.

In addition, many of the fire departments have also provided valuable support for emergency events such as storing and distributing sandbags and taking photos of impacted areas during flooding events; providing staff in support of the RDBN Emergency Operations Centre and sharing out the RDBN's communications during an emergency response.

Staff is recommending that the Rural Directors recommend to the Board to direct staff to establish a budget of \$7,500 per municipal and rural Fire Department in the region through the Emergency Preparedness Planning Service for Fire Department Emergency Services.

The funds would be used at the discretion of the individual Fire Departments to build response capacity.
