Expression of Interest Application

The Regional District of Bulkley-Nechako (RDBN) is excited to announce the Hazard, Risk, and Vulnerability Analysis (HRVA) program across the entire Regional District. Our region is facing significant issues when it comes to environmental-based hazards, such as flooding and urban interface wildfires. These hazards pose a risk to residents and expose our diverse region to potential vulnerabilities. In response, the RDBN is working to improve its overall emergency management system by completing a HRVA for each of the Electoral Areas to:

- develop a comprehensive understanding of what emergency hazards exist throughout the RDBN;
- develop a comprehensive understanding of the risks and vulnerability of residents; and,
- develop activities that improve awareness and the community's ability to withstand emergencies throughout the RDBN.

The Regional District would like to invite those who are interested in helping identify hazards, learn about emergency planning and be a part of building awareness on emergency preparedness in our region to be part of this process as a Committee member. **The interest application form must be submitted by May 15th, 2021.** All committee meetings will be held virtually using Zoom or another designated online platform or if permitted in a central location for the specific electoral area.

Responsibilities of the committee are as follows:

- Participate as an active member of the committee in 4 to 5 meetings over the next two years; and,
- Review reports in preparation for meetings

Note: If applicable, for each meeting, meals will be provided, and a travel allowance will be considered for those traveling from out of town.
