# Stellat'en First Nation RE: Lejac Residential School

At its June 10<sup>th</sup> Committee of the Whole Meeting David Luggi, Stellat'en First Nation provided a virtual presentation regarding the Lejac Residential School.

#### **Regional Broadband Infrastructure Service Bylaw**

The Board gave first and second reading to Regional Broadband Infrastructure Service Bylaw No. 1951, 2021 at its June 24<sup>th</sup> Board meeting. The bylaw has been forwarded to RDBN member municipalities for consideration of participation in the service.

#### Food Economy and Food Hub Assessment Report and Next Steps

The Board approved the Food Economy and Food Hub Assessment Final Report and reviewed next steps and roles moving forward. The RDBN's principle role will be a supportive role for individuals, organizations and businesses that wish to pursue different aspects of a broader marketing and distribution system.
