The expenditures for the first nine months of the year are exactly in line with the approved budget. The predicted interest revenue is lower than expected due to the decrease in interest rates in the last half of 2020 and with these low interest rates continuing through 2021.

A list of investments is attached to this report. The investments do not include accrued interest on investment certificates and so the total investments will not match the estimated revenue on the income statement.

That Stuart-Nechako Regional Hospital District Annual Budget Amendment Bylaw No. 82, 2021 be given three readings and adoption this 7th day of October, 2021. That Stuart-Nechako Regional Hospital District Capital Expenditure Bylaw No. 83 be given three readings and adoption this 7th day of October, 2021.

#### **Discussion:**

At the September 23rd Board Meeting, the Board made a motion to fund the Stuart-Nechako Manor roof replacement project up to a maximum of \$2,000,000.

Bylaw No. 82 proposes to amend the budget by moving \$2,000,000 from the Stuart Lake Hospital Capital project to future years (that is to calendar years 2023 or greater) and to include \$2,000,000 for the funding of Stuart-Nechako Manor (with \$1,000,000 being set aside for payment in 2021 and 2022).

Bylaw No. 83 authorizes the \$2,000,000 funding for the Stuart-Nechako Manor roof replacement project. The intent of this bylaw is to fund the lesser of 40% of the project or \$2,000,000. While a percentage of a project cannot be placed in a bylaw, the cover letter to Northern Health will clearly spell out this intent.
