Discussion

BACKGROUND

The RDBN boardroom is now equipped with technology that allows us to record our meetings, livestream them on Facebook or a YouTube Channel, or post them for viewing after the meetings have taken place. The purpose of this memo is to generate discussion regarding the options available and the desire of the Board.

Should the Board wish to livestream or post the meetings for viewing following the meetings, a policy in this regard will be brought forward for the Board's consideration.

A number of options to consider are:

- Which meetings will be livestreamed/posted Board or Board and Committees
- A number of layout options are available (we will display these during the discussion)
- How long should the recordings be kept? For Freedom of Information and Protection of Privacy reasons, staff would recommend only keeping the most recent recording
- Which platform should be used? Facebook/YouTube/RDBN Website/Others?
