<u>CALL TO ORDER</u> The meeting was called to order at 8:01 p.m.

BUSINESS:

Chair Fisher Welcomed Christine Gaw and Curtis Matthews to the

public hearing and read a statement introducing the application, making reference to the written submission,

and outlining the public hearing process.

Chair Fisher Asked Christine Gaw and Curtis Matthews if they had any

comments on Bylaw No. 1958.

Christine Gaw Said that the building location is not in her best interest,

and would prefer to see the building relocated to the northern part of the property across Lake Kathlyn Road. Christine said that she had concerns and questions with the location of the building in the floodplain and the on-

site sewage disposal system.

Jason Llewellyn Said that a building permit is required prior to use of the

building as a dwelling. As part of the building permit approval process the Planning Department will ensure that any applicable floodplain regulations are complied with, and that proper process is followed regarding the on-site

sewage disposal system.

Christine Gaw Questioned why the building was located south of the

road and expressed concern that it impedes her views. She restated her preference that the building be located

north of the road.

Curtis Matthews	Said that they want to use the property for a 2 nd dwelling for family. There is a lack of rental accommodation in the region. The area of his property south of the Lake Kathlyn Road is 1.25 acres in size and is a reasonable and logical location for a 2 nd dwelling. He has a letter from a qualified person stating that the area can accommodate an on-site sewage disposal system, and the dwelling will look nice.
Christine Gaw	Said she remained concerned that there will be a dwelling in the proposed location and would like to see it relocated to the area north of the road given the potential visual and noise impacts.
Curtis Matthews	Said that the new dwelling will create normal household noise and that the single story dwelling will not negatively impact anyone's views.
Chair Fisher	Called for comments on Bylaw No. 1958 three times.
Chair Fisher	Closed the hearing at 8:16 P.M.
