#### **VERBAL REPORTS AND COMMITTEE CHAIR REPORTS**

Chair Parker reported that he had met with RDBN staff and Rural/Agriculture Committee

Agriculture Coordinators. He expressed his appreciation for the

work and local knowledge of both RDBN Agriculture

Coordinators.

Connectivity Committee Chair Riis-Christianson commented that a Connectivity

> Committee Meeting will take place in October to discuss the importance of developing a strategy and options moving forward

to improve connectivity for area residents.

Recycling options

Waste Management Committee Director Fisher mentioned that the Province announced it was taking action to recycle more products as part of a five-year plan to advance recycling in B.C. The Ministry of Environment and Climate Change Strategy also indicated it will explore how to regulate the recycling of more packaging paper products within

the ICI sector.

Northern BC Solid Waste Management (Virtual) Forum -October 12 & 13, 2021 Director Fisher encouraged the Board to register for the Northern BC Solid Waste Management (Virtual) Forum October 12 & 13, 2021. He also spoke of inviting schools within the region to attend.

Teleconference with the Honourable, Adrian Dix, Minister of Health
-September 22, 2021

Director McGuire spoke of the teleconference meeting with the Honourable Adrian Dix, Minister of Health September 22, 2021 with northern Mayors, Chairs and CAOs to discuss the COVID-19 Pandemic. Director McGuire spoke of providing feedback to Minister Dix's staff regarding the development of a visual meter for communities to show vaccination rates in each community.

Town of Smithers

Director Atrill expressed her gratitude regarding the Town of Smithers having staffing levels return to normal and positions filled. She noted the uncertainty created by vacant job positions.

National Truth and Reconciliation Day at Lejac -September 30, 2021 Director Storey announced that a National Truth and Reconciliation Day Event will be held at the site of the Lejac Residential School on September 30<sup>th</sup> from 12:00 to 3:00 p.m. for anyone wanting to attend.

<u>District of Vanderhoof Staffing</u> Levels Chair Thiessen mentioned that the District of Vanderhoof has recently had the same experience as the Town of Smithers in regard to staffing. He noted the District has now filled its job postings. He recognized Northern Development Initiative Trust for their Internship Program due to a number of employees that the District of Vanderhoof has hired that participated in the program.

COVID-19 Pandemic

Director Riis-Christianson thanked Chair Thiessen for his opening comments regarding the challenges being felt and observed due to the COVID-19 pandemic and current strain on communities. He spoke of the importance of being calm and providing reassurance to residents and providing accurate information for individuals to make informed decisions.

Director Atrill mentioned that the arena is open in Smithers and staff are preparing for the current Provincial COVID-19 regulations and vaccine passport program for adult recreation. She spoke of the impacts of past COVID-19 restrictions and the ability to provide programing under the present COVID-19 regulations.

Director Atrill attended a protest that took place in Smithers concerning businesses addressing the Provincial Vaccine Passport requirements. She noted the number of different issues and the angst with members of the protest. Director Atrill mentioned the importance of focusing on the good and positive to continue to move forward.

Director Newell spoke of the fear that is overwhelming some people and noted that with differing opinions in regard to COVID-19 Vaccine Passports it has become challenging to be inclusive of one another, but it is so important.

COVID-19 Pandemic - (Cont'd) Director Funk spoke of the challenges of COVID-19 and encouraged the community to be responsive to the Provincial regulations and vaccine passports.

> Chair Thiessen spoke of the importance of supporting medical workers and staff at the region's hospitals.

He attended the meeting with Minister Dix as well as meeting with Shirley Bond, MLA Prince George-Valemount and BC Liberal Party Interim Leader. He noted the strain the pandemic has had on provincial leaders as well.

Chair Thiessen spoke of different organizations that have recently announced their support of vaccinations.

He brought forward concerns regarding COVID-19 patients filling hospitals and limiting the ability for accident victims and other medical procedures to receive the care they need. He spoke of removing the focus from vaccines and moving the focus to caring and rebuilding communities. He noted the next 6-8 weeks may be challenging.

Chair Thiessen mentioned that as leaders they can reach out to community groups and hospitals to give thanks and provide support. Director Atrill spoke of individuals in the Town of Smithers working to provide citizen support to healthcare workers.

Director Brienen commented on the importance of messaging from local government leaders and supporting others and one another during these stressful and challenging times.

Discussion took place regarding the pressure and overwhelming workload for health care workers.

### September 7-17, 2021

2021 UBCM Virtual Convention The RDBN Board of Directors reported that the 2021 UBCM Virtual Convention Minister Meetings between September 7-17, 2021 went well.

> Director Funk noted the Village of Burns Lake had positive and collaborative conversation at the table notably with the Minister of Advance Education and Minister of Indigenous Relations and Reconciliation.

Director Fisher commented that he participated in a number of 2021 UBCM meetings from the Town of Smithers Council Chambers. He expressed his appreciation to the Town of Smithers for the opportunity.

Director Storey thanked the Board for its support in electing her as UBCM Director at Large.

The Honourable Lana Popham, Ministry of Agriculture and Fisheries

Director Parker thanked those that participated in the meeting and expressed his gratitude to the RDBN Agriculture Coordinators for assisting with the briefing information

#### BC Emergency Health Services (BCEHS)

Director McGurie indicated that after meeting with BC Emergency Health Services during the UBCM Convention she looks forward to having further follow up with BCEHS when a meeting can be scheduled between BCEHS and Stuart-Nechako Regional Hospital District.

Director Storey thanked Director McGuire for her work in regard to concerns with BCEHS staffing levels in small rural communities.

## The Honourable David Eby, Attorney General and Minister responsible for Housing

Director Atrill mentioned that the Town of Smithers UBCM meetings focused on the topics of land acquisition and housing issues. Director Atrill was also the lead speaker for the RDBN regarding communities in the region experiencing an increase in homelessness due to mental health and addiction struggles. She mentioned that while the meeting took place she witnessed an overdose taking place in the homeless camp located near the Town of Smithers municipal office. Nathan Cullen, Minister of State for Lands and Natural Resource Operations and MLA Stikine also participated in the call.

Director Storey commented that the Village of Fraser Lake also met with Minister Eby to discuss housing, respite and senior housing in the community.

The Honourable Katrine Conroy, Minister of Forests, Lands, Natural Resource Operations and Rural Development
Director Brienen mentioned that in speaking with Minister Conroy the Modernizing Forest Policy in British Columbia intentions paper was brought forward. He mentioned that as Chair of the RDBN Natural Resources Committee he will bring the Paper forward at the next Committee meeting.

Director Funk mentioned that in discussions with Minister Conroy concerns were raised regarding the potential change from tabular rates to stumpage rates and the impacts to Community Forests. Director Storey also mentioned that the Village of Fraser Lake raised the same concern and spoke of the importance of ensuring that Community Forests continue to benefit communities.

#### Northwest BC Resource Benefits Alliance (RBA)

Director Brienen noted that the RBA has a meeting scheduled with the Honourable Josie Osborne, Minister of Municipal Affairs on September 28, 2021. He spoke of RBA conversations at UBCM and that the Province referenced strong fiscal futures in the long-term but the impact in the north is now.

Chair Thiessen noted that the District of Vanderhoof UBCM meetings with Premier Horgan provided an opportunity to briefly discuss RBA.

The Honourable Lisa Beare, Minister of Citizens' Services
