BACKGROUND

At the June 16, 2022 Natural Resources Committee Meeting, a motion was passed regarding engaging with Al Gorley or Ray Schultz to develop and prioritize the top forestry issues in the region for RDBN advocacy. On August 16th, Al Gorley attended the RDBN and met with Chair Brienen, Director Thiessen, and staff to have a conversation about forestry issues and the RDBN's possible approach to the issues moving forward.

Al Gorley expressed an interest in assisting the RDBN and provided the attached document titled "Possible Approaches to Regional Forestry and Natural Resource Challenges" for the Board's consideration.

Possible Approaches

TO REGIONAL FORESTRY AND NATURAL RESOURCE CHALLENGES



September 2022

Situation

High economic dependence on forest harvesting and manufacturing High level of uncertainty and concern due to:

- Constraints on the historical timber supply arising from
 - Legacy of the Mountain Pine Beetle epidemic
 - Wildfires
 - Evolving / changing provincial forest policies
- Incomplete information about how the Declaration on the Rights of Indigenous Peoples Act (DRIPA) will be implemented
- Perceived lack of alignment between regional and provincial interests...

... etcetera

Examples of current uncertainties

- Status and direction of G2G (Province and First Nations) agreements, and potential community impacts.
- Economic implications of old growth deferrals (including BCTS) and the longer-term approach.
- Tenure transfer policies and the implications for jobs and businesses in the region.
- Stumpage policies, including potential changes to community forest stumpage rates and the local economic consequences.
- On-going viability of local manufacturing operations and potential for value-added.

What is the role of the Regional District of Bulkley Nechako in forestry and natural resource management?

- FORMAL MANDATE
- PUBLIC EXPECTATIONS AND OPPORTUNITY

Historically forced to react on an ad-hoc basis when becoming aware of a proposed initiative.

Key challenges

Information

 Access to timely, relevant, complete, and coordinated information and analysis to support informed input or participation by the RDBN or its representatives.

Process

 Clear and predictable mechanisms for receiving information, engaging in dialogue, and giving valued input to plans and decisions, including feedback.

Capacity

 Resources to engage sufficiently on key matters, ask the right questions, and facilitate development and documentation of high quality input, including coordination with other local governments with similar interests.

Potential actions

Short-term (more focused and proactive within existing mandate)

- Communicate proactively with Provincial and FN governments (political and bureaucracy).
- Continue to work through regional and provincial local government associations to address specific issues.
- Set priorities adopt a screening process for known and expected issues, for example:
 - local issue with a significant direct impact on one or more communities within the RDBN (e.g., AAC / apportionment).
 - local or regional issue with a significant indirect impact on one or more communities within the RDBN.
 - regional or provincial issue with a disproportionately large impact on RDBN.
 - provincial issue with a proportional impact on RDBN.
- Utilize existing capacity (including trusted local advisors) ad hoc, or establish an informal advisory committee or task force of knowledgeable people to support the RDBN Board & committee(s).
- Invite public input to "position" or "interest" statements.
- Using best information available, develop "position" or "interest" statements on key and emerging issues and communicate them widely.
- Others?

Potential actions

Longer term (build on short-term to formalize mandate and address key challenges)

- Create and fund a standing position or facilitated advisory group.
- Develop a formal information and engagement protocol with key ministries.
- Regional "leadership" table with Province/FN/local government.
- Develop and promote (preferably with adjacent communities, including FN communities) a regional forest sector vision and strategy. This could be an adaptation of work done by the beetle coalitions several years ago.
- Work with like-minded local governments to establish a facilitating mechanism (e.g., OBAC model).
- Work through regional and provincial associations to give municipalities a formal (legal) role.
- Find ways to ensure institutional history on forest management matters.
- Others?

Next steps?

- Address immediate priorities (top 2 or 3 most urgent).
- Reach out to First Nations' government leaders.
- Identify additional potential short and longer-term actions.
- Involve a small number of local experts in a strategy session.
- Identify ways to more effectively utilize existing mechanisms (e.g., Skeena Roundtable).
- Identify capacity opportunities.
- Others?
