## **ELECTOR REGISTRATION**

There is no need to pre-register to vote as the registration of all electors for this election will take place at the time of voting. You will be required to make a declaration that you meet the following requirements:

- 18 years of age or older on general voting day
- Canadian citizen
- resident of BC for at least 6 months immediately preceding the day of registration
- resident of OR registered owner of real property in Electoral Area C for at least 30 days immediately preceding the day of registration, and
- not disqualified under the *Local Government Act* or any other enactment from voting in an election or otherwise disqualified by law.

**Resident electors** must produce **2 pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

**Non-resident property electors** must produce **2 pieces of identification** (at least one with a signature) to prove identity, **proof** that they are entitled to register in relation to the property, and, if there is more than one owner of the property, **written consent** from the majority of the property owners. **NON-**

## RESIDENT PROPERTY ELECTORS MAY ONLY VOTE ONCE REGARDLESS OF THE NUMBER OF PROPERTIES THEY OWN.

Proof of ownership of the property must be provided including the legal description and physical address (tax notice, utility bill, or recent copy of the Land Title Search).

It is recommended that Non-Resident Property Electors contact the Regional District of Bulkley-Nechako in advance of General Voting Day to be certain that all requirements have been met.
