BACKGROUND

Upon completion of the RDBN Food and Agriculture Plan in April 2020, staff committed to providing updates on the Implementation Strategy. The Plan is currently in Phase 1: 2020-2023. Several Priority Area actions have been (or are soon to be) completed. For reference, the eight top Priority Areas from the RDBN Food and Agriculture Plan are:

- 1. Support producers in navigating government policies and requirements
- 2. Prepare for emergencies
- 3. Develop the food and agriculture sector and market(s) for RDBN goods
- 4. Engage a broad audience in regional food and agriculture activities and information
- 5. Prevent and manage invasive and harmful species
- 6. Ensure agricultural policies are in-place and consistent across the region
- 7. Increase climate change resiliency and adaptation capacity
- 8. Continue to build capacity for effective and strategic implementation

Each Priority Area includes specific actions which are included in the three-phase implementation strategy. The phases contain concurrent actions. Phase 1 is not required to be complete prior to Phases 2 and 3, and each phase includes short, medium or long-term goals.

The following Implementation Actions remain underway and are ongoing through all three Phases:

3.2 Continue to update and distribute the Connecting Producers and Consumers Guide annually.

RDBN Public Engagement Summer Student, with permanent staff support, reached out to all producers to update the online directory, as well as attended each community's market to promote the program.

4.1 Continue to support and build relationships and networks around RDBN food and agriculture.

6.2 Continue to advocate to senior levels of government and industry around issues that impact RDBN producers.

The key issue currently is the critical lack of veterinarians in the region and Province. The RDBN continues to raise this concern with the Province through letters and at UBCM meetings. The RDBN is also supporting an Economic Impact Study on the lack of veterinarians being undertaken by the BC Cattlemen's Association to increase the data available to support long-term investment in solutions.

8.2 Maintain the Agriculture Coordinator Position.

8.3 Compile and consolidate quantitative and qualitative data on food systems and agriculture in the RDBN.

Once released by Statistic Canada, the RDBN will include all relevant agriculture data in our data warehouse, which is available to all regional partners. This is the first time the updated warehouse will include this data.

8.4 Continue to be a learning organization.

RDBN Ag Coordinators continue to participate in a province-wide systems change project for agricultural support spearheaded by Alberni-Clayoquot Regional District

The following Implementation Actions are associated with specific project work that is already complete, or well underway:

1.2 Create and disseminate producer-focused tools to support clarity with the multiple levels of government regulation.

In addition to the Newsletter and Podcast series produced in the last year, additional podcast episodes and accompanying factsheets are under development for distribution.

2.2 Strengthen Livestock Emergency Preparedness

Agriculture Staff support the development and dissemination of emergency preparedness materials and information for local producers.

5.5 Encourage private landowners to prevent and manage all weed, noxious and native.

RDBN Ag Coordinators continue to work with the Northwest Invasive Plant Council to identify and manage high-priority agriculture sites and increase awareness of the Landowner Rebate Program.

7.2 Increase climate risk mitigation and adaptation for agricultural lands.

Staff also continue to work with the Climate Action Initiative on priority items. Projects underway this year include the Pollinator Assessment and Agricultural Climate Analysis for Bulkley-Nechako and Fraser-Fort George.

7.3 Reduce organic and plastic agricultural waste in the landfill.

Agriculture staff continue to support the success of the CleanFarms BC Pilot for agricultural plastic recycling in the region.

BACKGROUND

RDBN Staff support the work of the Climate Change Adaptation Program. The Pollinator Assessment and Agricultural Crop/ Climate Analysis for the Bulkley-Nechako and Fraser-Fort George Regions of BC was competed with RDBN staff and financial support.

1) What's Pollinating Crops in BCs Central Interior Fact Sheet 2022

What's pollinating crops in BC's Central Interior?

A first of its kind project in Bulkley-Nechako and Fraser-Fort George is collecting information on the types of pollinators present in agricultural crops and how these pollinators are being affected by climate change.

The project is working with local producers over 2 years (2021, 2022) to collect pollinators on farms from Smithers to the Robson Valley and is using DNA barcoding to identify them. This research is being compiled into a "baseline dataset" of pollinator species present in the region. This dataset will support future research into how climate change is affecting the health and distribution of regional pollinators, and into farm practices that support pollinator health and resilience.

Over 200 arthropods (insects and spiders) that are likely pollinators are present in agricultural areas of Bulkley-Nechako and Fraser-Fort George.

We're still counting, but on farmland across the region you can find at least:



63 pollinating bee species: including 13 different bumblebee species, 14 species of mining bee (Andrenidae), and 16 species of mason and orchard bee (Megachilidae)

102 pollinating fly species: including 63 species of hoverfly **30 species of butterflies and moths, 9 beetle species, 3 spider species**

Many of these species (particularly the hoverflies and the spiders) have additional benefits for crop production, because they are also predators and can help control common crop pest species. Some groups (particularly mason bees, important pollinators of alfalfa) are more abundant and/or diverse near forests.

The most common pollinators in this region are:

How is climate change affecting pollinators in the region?

Climate change can affect pollinators directly (e.g., heat causes mortality in species with low thermal tolerance) or indirectly, by altering plant growth and physiology (which may alter nectar rewards, pollen quality, timing of flowering, etc.).

High pollinator biodiversity can buffer systems against pollination declines induced by many of the stressors that are exacerbated by climate change. Managing landscapes to maintain high pollinator biodiversity is likely the best way to protect against future pollination deficits associated with climate change.

How your farm (and farm practices) can support pollinators:

Preserve what you have: identify areas with native plants that are currently used by pollinators, and forest-adjacent areas with sandy soils (often used for nesting). Limit disturbances in these areas (i.e., don't mow, till, or compact soil).

Allow native plants to bloom in field margins and non-productive areas.

Retain forest patches within and adjacent to agricultural areas.

Consider selecting cover crops that can provide nectar and/or pollen (see this cover cropping guidebook for details).

Create new pollinator habitat: if you are considering planting for pollinator habitat enhancement, Pollinator Partnership Canada has planting guides for each ecoregion of Canada and an interactive tool to help in selecting plants: https://pollinatorpartnership.ca/en/find-your-roots
