#### **BACKGROUND**

Staff have created mapping with multiple data layers to assist Directors with prioritizing remaining underserved segments of their Electoral Areas. The map layers include:

- Federal ISED speed mapping (which determines eligibility for grant programs).
- Initial project area suggestions from the 2019 TANEx engineering report.
- Potential project areas for which we understand the funding applications have been submitted. (Some of these remain at the in-camera stage and will not be reviewed individually at this time).
- Project areas that remain unserved (where the RDBN is not aware of any projects or funding applications underway).

Staff will provide an overview of the ArcGIS map to the Committee at this time via screen share. Maps of specific data layers and areas can be printed upon request.
