- Construction underway
- Earthworks/construction in Summer 2022
- Completion scheduled for September, 2024
- Transitioning between the old and new facility October to December, 2024
- No changes to the project budget.

- Northern Health's 'Let's Talk' resource provides information
- Ribbon cutting will be determined in collaboration with the Ministry of Health
- At the completion and transition to the new facility, the old facility will be deconstructed as per the Design-Build Agreement
