CORRESPONDENCE:	No written submissions to this Public Hearing were received.
CALL TO ORDER:	The meeting was called to order by Chair Parker at 7:00 pm.
BUSINESS:	
Chair Parker	Chair Parker provided an overview of Bylaw No. 2006 and Bylaw No. 2007 and the Public Hearing process. Chair Parker stated that the Public Hearing package is available in the binder at the sign-in table and on the Regional District's website.
Chair Parker	Asked applicants Kenneth McAllister and Judith Troberg if they had any comments.
Kenneth McAllister	Said their application is for the property they own at 731 Francois Lake Road and is not for making changes to any other properties.
Chair Parker	Asked if there were any additional comments.
Richard Hummell	Asked if the proposal effects the regulations on their own property.
Chair Parker	Said the application is requesting to rezone and redesignate on the application property only.

Judy Troberg	Asked if the Regional District knows why the property is designated and zoned the way it is.
Chair Parker	Noted the property would be too small to be zoned RR1 today. Directed the question to Danielle Patterson, staff.
Danielle Patterson	Said property background did not provide clear answer as to why a portion of the property was designation RE and zoned RR1 in the past.
Chair Parker	Asked for any additional comments a first time.
Judy Troberg	Asked if she wanted to rezone another parcel she owns if this rezoning would create a precedent.
Chair Parker	Said it would not create a precedent as each application is considered based on it own merits and specifics.
Chair Parker	Asked for any additional comments a second time. No comment received.
Chari Parker	Asked for additional comments a third and final time. No comment received.
Chair Parker	Adjourned the Public Hearing at 7:08 pm.
