Re: ALC Removal of Soil Application referral – Crown land - gravel operation (Part of Primary: DL 4107, Range 5, Coast District)

Dear Cameron Kral,

Thank you for providing Ministry of Agriculture and Food (Ministry) staff with the opportunity to comment on a proposed Agricultural Land Commission (ALC) application to continue operating a gravel operation within a ~7.6-hectare portion of the subject 130.96-hectare parcel, located west of Houston, north of Morice River, and within the Agricultural Land Reserve (ALR).

Ministry staff offer the following comments:

- The proposal's Reclamation Report and Land Capability Assessment (Chaplin Construction Ltd, January 2024) includes a Reclamation Plan. While the Plan package does not include elevation drawings, it states the site may result in up to a significant seven-meter depths from existing grade. And while it also states that the soils (internal highwalls) between two other adjacent properties may also be removed, Ministry staff are unclear as to where the proposed stockpiles and windrows for recontouring the area will be stored, or what happens if there is not enough soil to reach the 3:1 slope recontouring objective, or, also significantly, if water fills the cavity and doesn't disperse.
- Regional District staff may want to review, with the applicant, <u>ALC Policy P-13</u> (<u>Reclamation Plans for Aggregate Extraction</u>) (adopted April 2021 and includes Appendix A 'Best Management Practices for Aggregate Extraction Activities

- The Report also includes an Invasive Plant Management Plan. Weeds can greatly reduce the productivity of agricultural areas and under the provincial <u>Weed Control</u> <u>Act</u> the land occupier has a legal obligation to control noxious weeds on the site. Gravel operations are continually disturbed sites, perfect for the establishment of invasive plants. To help reduce the spread of weeds Ministry staff encourage site-specific weed prevention and control plans that place a special emphasis on clean equipment.
- In the short term, the subject operation will not directly contribute to agricultural production on the property. Based on the available information, given the proposed depth of soil extraction and limited information on water management, Ministry staff are uncertain regarding the proposal's long-term benefit to agricultural production, both on and off the site. It is worth noting however that nearby sources of gravel are important to most farm operations. Farm operations can utilize gravel in many aspects of their operations, reducing mud, improving ease of machinery movement, and improving access points for livestock, particularly at watering sites or high traffic areas. Hauling gravel long distances adds cost to delivery.
