Reports

Support for the Regional Transit Service

At the March 13th Rural Services Committee meeting, the Committee recommended that the Board support the utilization of the Northwest BC Regional Funding Agreement (Resource Benefits Alliance (RBA)) funds for the 2025 to 2028 calendar years.

Community Works Fund

The Board approved Community Works Funds for the Burns Lake Public Library HVAC Replacement and for the Fraser Lake Arena/Curling rink ammonia chiller.

Area B (Burns Lake Rural) and E (Francois/Ootsa Lake Rural) Economic Development Services

The Board approved, at its March 13th Board meeting, grants to the Village of Burns Lake for a Faces and Places marketing project and Website Redesign project from Area B (Burns Lake Rural) and E (François/Ootsa Lake Rural) Economic Development Services.

Illegal Dumping Mitigation Strategy

The Board resolved to write a letter to the Minister of Environment and Parks requesting that the Ministry make illegal dumping site clean up and enforcement of regulations against illegal dumping on Crown land a financial and human resource priority. The Board further resolved to implement a community clean-up program.

Community Resiliency Investment Program – 2025 FireSmart Community Funding & Support Application

The Board supported the submission of a grant application to the Union of BC Municipalities Community Resiliency Investment (CRI) Program – FireSmart Community Funding & Support, to extend the FireSmart Program for an additional two-year term.

Northwest BC Regional Funding Agreement (RBA)

The Board approved a Long-term Development Plan and the 2025 Annual Development Plan for the RBA Funding Agreement which outlines the intended policies, operational activities and capital investment and how the funds will be contributed to the objectives outlined in the agreement.

2025 Budget

The Board approved its 2025 Budget and Five-Year Financial Plan Bylaw at the March 27th meeting.

Premier's Task Force on Agriculture and Food Economy

At the March 13th Board meeting the Board received information regarding the Premier's Task Force on Agriculture and Food Economy in response to uncertainty created by the potential implementation of U.S. government tariffs on Canadian agricultural exports and resolved to write a letter to the Premier requesting consideration of northern representation.
