



## Wildfire Mitigation Program (WMP)

The FireSmart WMP was designed to engage homeowners in voluntary wildfire mitigation activities by offering a free, confidential, and professional home assessment with property-specific recommendations.

The assessment process accurately evaluates a home's exterior and property for wildfire exposure, while engaging the homeowner in their unique risk and ways to reduce it.

### The Process

- ✓ **FOR THE FREE ASSESSMENT:**  
Sign up and receive a confidential FireSmart WMP Assessment.
- ✓ Receive your FireSmart Report through postal or email.
- ✓ **FOR THE REBATE:**  
Complete priority actions outlined in the '*general comments*' section of your report.
- ✓ Compile Information:
  - Photos of completed work
  - Paid invoices/record of hours
  - Mailing address

### Priority Actions

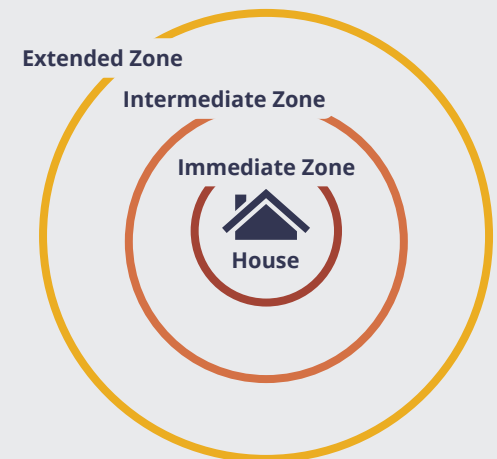
Eligible actions are determined by examining the Home Ignition Zones. These zones are listed in order of priority to help us identify what poses the greatest wildfire risk to each home.

If you complete eligible activities that were recommended in your assessment, you may be eligible for a 50% reimbursement up to:

Immediate Zone **0-1.5m** max rebate of \$5000, or  
Intermediate Zone **1.5-10m** max rebate of \$2500, or  
Extended Zone **10-30m** max rebate of \$1000

If you have any questions, feel free to contact RDBN FireSmart staff to discuss rebate eligibility prior to completing the recommendations.

Rebate amounts in the extended zone will be considered on a case-by-case basis, at the discretion of the Regional District of Bulkley-Nechako.

## FIRESMART REBATE GUIDE

### Rebate Program

---

After the assessment, homeowners will receive a detailed report outlining specific actions they can take to make their homes more resilient to wildfire.

Rebates are available on labour and material costs or contractor invoice cost at 50% as per Priority Actions per address, depending on the priority risk level of the activity being completed. The rebate will be reimbursed by the Regional District of Bulkley-Nechako upon successful completion of eligible actions, and after receiving the following information:

- Photos of completed work
- Paid invoices/record of hours
- Mailing address
