1) That the Committee recommend that the Board authorize contributing up to \$33,000 of Electoral Area E (Francois/Ootsa Lake Rural) Canada Community- Building Fund BC allocation monies to a Recreation Infrastructure Project for the Grassy Plains Community Hall, and further,

## (participants/weighted/majority)

2) That the Committee recommend that the Board authorize the withdrawal of up to \$33,000 from the Federal Gas Tax Reserve Fund.

#### **BACKGROUND**

The Grassy Plains Community Hall has experienced significant deterioration of the foundation due to rot caused by water. A structural review performed on the Hall indicated that, due to the foundation damage, the building is not safe for use by the public unless/until repairs are completed. A subsequent review of the roof indicated that it is suitable for the use intended. The Hall Society, based on the engineer's reports, decided to pursue repairs to the foundation to ensure the ongoing use of the facility.

A CWF contribution of \$50,000 was approved in 2022 to begin the engineering work, with another \$160,000 approved in 2024 to begin the construction work. The project, which experienced some delays but is now underway, has a shortfall of \$33,000 to see the foundation repairs to completion. This \$33,000 contribution will complete the project budget and enable the foundation repair work to occur this year.

#### **BACKGROUND**

A day-long gathering of food producing, non-profit agricultural organizations was held on March 22, 2025, at the Heritage Church in Burns Lake. Representatives from three non-profit organizations attended: Groundbreakers Agriculture Association, the Nechako Valley Food Network, and the Fraser Lake Eco-Coop. The session was facilitated by Mark deHoog, of Blue Ocean Group. The Regional Agriculture Coordinator was also in attendance.

Attached please find a report prepared by Mark deHoog following the event that summarizes the key themes and findings.

Next steps involve re-engaging with agricultural non-profit organizations in the region to determine if there is interest in a day-long workshop that covers topics such as:

- Governance best practices

## **Executive Summary**

This report synthesizes the discussions and findings from the recent consultation meeting on March 22, 2025 with the RDBN and several Non-Profit Agricultural Groups in the Region. The primary focus was connection with one another and discussion on the challenges and opportunities for developing food security strategies in the region, emphasizing funding, government support, community engagement, and collaboration with First Nations communities. Strategic planning, youth involvement, and partnerships with local businesses were also identified as crucial for success.

Key findings include the necessity of sustainable funding, the role of food hubs in strengthening local food systems, and the need for effective collaboration among stakeholders. Challenges such as high infrastructure costs, regulatory restrictions, and limited processing facilities were also highlighted. Several actionable steps were proposed to address these issues, including lobbying efforts, strategic alliances, and enhanced information sharing.

## Food Security and Sustainable Development

Addressing food security in the Bulkley Nechako region requires a multifaceted approach that combines sustainability, accessibility, and economic resilience. The consultation explored how food hubs can act as a cornerstone for regional food development, strengthening the local food economy and ensuring year-round access to nutritious, affordable food.

## **Local Food System Enhancement**

Improving the local food system involves creating effective distribution channels, supporting producers, and building public awareness around the benefits of buying local. Examples from other regions offer scalable models, but success depends on tailoring these initiatives to the unique needs and capacities of local communities.

The meeting emphasized the importance of making local food more accessible and sustainable. Several initiatives, including food hubs and farm-to-school programs, were discussed as potential models for regional adoption.

Successful food hubs in the Kootenays and Kamloops serve as examples of how structured operational plans and collaboration can support local food systems. However, adapting these

models requires community-specific strategies that consider local resources and funding challenges.

## **Community Gardening and Youth Engagement**

Youth involvement is a vital element of a thriving local food system. Programs that connect youth to gardening and farming help nurture a new generation of food leaders. This section highlights the successes and limitations of current efforts and identifies strategies for deepening youth engagement through schools and community partnerships.

Projects such as the Young agrarians and Youth On Farm (Groundbreakers) program demonstrate the value of engaging young people in sustainable agriculture. However, these programs face issues related to compliance, funding, and staff availability. Schools play a key role in these efforts, but their level of engagement varies.

## Volunteer and Community Engagement Strategies

Volunteers are the backbone of many food-related initiatives in the region. Sustaining momentum and avoiding burnout requires intentional strategies that value, support, and empower volunteers. This section offers insights into practices that can enhance community participation and long-term project stability.

Sustaining community-driven initiatives requires a well-structured volunteer framework. Recognizing and incentivizing volunteer contributions can enhance retention and engagement. Recommendations include:

- Establishing formal recognition programs for volunteers.
- Providing small stipends or benefits for long-term volunteers.
- Encouraging local businesses to support volunteer efforts through sponsorships.

## **Current Landscape of Non-Profit Orgs**

The post-pandemic environment has created both urgency and opportunity for food development. This section maps out the current state of food infrastructure, outlines the barriers organizations face, and lays the groundwork for potential collective solutions to strengthen food networks across the region.

Post-pandemic, many organizations have struggled with:

- **Resource Constraints:** Limited funding and human resources have made it difficult to sustain operations.
- **Volunteer Fatigue:** Many initiatives rely heavily on volunteers, who often experience burnout due to overcommitment and lack of recognition.

- **Limited Funding Opportunities:** Grants often require organizations to provide upfront capital, making it challenging for under-resourced groups to access funding.
- Lack of Coordination: Organizations working toward similar goals often operate in silos, leading to inefficiencies and missed opportunities for collaboration.

## Strategic Collaboration and Information Sharing

Effective collaboration is essential to avoid duplication of effort and to maximize limited resources. Participants voiced a strong desire for better coordination and knowledge exchange. This section explores the importance of building formal alliances and communication frameworks across the region.

One of the central themes of the meeting was the need for improved collaboration among regional organizations. Participants expressed concerns over duplicated efforts, lack of communication, and insufficient information-sharing mechanisms. Some organizations reported experiencing challenges with idea appropriation, where their initiatives were used by others without collaboration or credit.

To address these concerns, participants suggested **establishing formal partnerships** and implementing **clear protocols for information exchange**. These steps would help protect intellectual contributions while fostering an environment of cooperation and shared success.

## Regional Food Networks and Their Roles

## **Groundbreakers Collective**

Groundbreakers is a key player in the regional food movement, leading with a grassroots approach to education, sustainability, and advocacy. This section outlines their work and presents ideas for expanding their reach and impact through enhanced partnerships.

Groundbreakers is a grassroots organization focused on food sovereignty and sustainability. It works to create resilient food systems by supporting local farmers, hosting educational workshops, and developing community food initiatives. Their key initiatives include:

- Educational Programs: Providing training on sustainable agriculture and food security.
- Community Support: Assisting local farmers with resources and networking opportunities.
- Advocacy Work: Engaging with schools and community to support local food production and sustainable practices.

Despite their impact, Groundbreakers faces funding challenges and a need for more extensive community engagement. Expanding partnerships with regional organizations could help enhance their reach and effectiveness.

## **Nechako Valley Food Network**

As a locally driven initiative, the Nechako Valley Food Network plays a crucial role in addressing food insecurity and supporting producers. This section presents their strengths and challenges

The Nechako Valley Food Network is dedicated to strengthening local food systems through education, advocacy, and community-driven initiatives. Its primary goals include:

- Food Security Programs: Implementing food-sharing initiatives and supporting local food hubs
- Farmer and Producer Support: Providing training and financial guidance for smallscale farmers.
- **Sustainable Practices Promotion:** Encouraging environmentally friendly farming methods and reducing food waste.
- NeighborLink provides emergency food access but does not function as a full-scale food hub (Vanderhoof)

One of the network's major challenges is securing long-term funding to sustain its programs. Strengthening collaborations with local governments and businesses could provide additional support and resources.

## The Eco Co-op

The Eco Co-op is a unique organization aiming to integrate food security with cultural, environmental, and youth development goals. This section examines their innovative model, existing barriers, and potential for scalable impact through partnerships and social enterprise.

The Eco Co-op is an emerging Co-op with a compelling vision. They are dedicated to building community capacity, enhancing food security, promoting local arts and culture, and supporting youth engagement. It operates in an ecologically responsible manner while fostering regional collaboration.

## Key Challenges

Despite its strong mission, the Eco Co-op faces several obstacles:

- **Economic Downturns:** The closure of primary employment sources has placed financial pressure on the community and the co-op.
- Funding Limitations: Access to grants and investor support remains a challenge, particularly because the co-op is not Indigenous-owned, limiting eligibility for certain funding streams.
- **Community Capacity Issues:** With a small population of 1,000 residents, many of whom are either elderly or young, volunteer availability is limited.

## **Observations**

- Limited existing food hubs in the region.
- Successful examples from other regions demonstrate the importance of strategic planning and financial sustainability.
- Funding remains a significant challenge for many organizations. Alternative approaches such as cooperative investment, community-backed funding, and social enterprise models can help diversify revenue streams.
- Additionally, collaboration with universities and research institutions can provide opportunities for grants and strategic partnerships. The Eco Co-op has already taken steps in this direction by partnering with academic institutions to conduct feasibility studies for sustainable business planning.
- A strategic point of front line contact in Schools is the best way of implementing. eg -Talk to a teacher not an admin.

# What are the Elements of a Successful Food Hub?

The group spent some time discussing what was needed for a successful food hub. A successful food hub must go beyond logistics and infrastructure—it must be a community-driven, financially viable initiative that adapts to local realities. This section breaks down the key components the group identified for success and lessons from other regions.

- Sufficient funding to cover operating costs.
- Government support to supplement volunteer efforts.
- Integration of educational and community engagement components.
- Adaptation to regional needs, including First Nations collaboration.
- A solid and adaptable business plan that takes into account regional factors and revenue streams from the start

## **Challenges and Solutions**

## Food Processing and Retail Issues

- **Limited Processing Facilities**: Small-scale producers struggle with inadequate facilities. leading to sales difficulties.
- Market Access: Producers need support in retail strategies and product presentation.
- Infrastructure Costs: High costs have led to the failure of previous food hub initiatives.

## **Potential Solutions**

- Revenue Generation Strategies: Incorporating workshops, meeting spaces, and retail components.
- **Niche Market Focus**: Examples of farms targeting specific products like garlic and organic vegetables.
- Collaboration with Local Businesses: Food hubs partnering with restaurants to ensure stable demand.

## Strategic Development of a Food Hub

## **Building a Sustainable Model**

- Determining the primary function: Retail vs. Processing.
- Learning from successful models, such as multipurpose facilities incorporating commercial kitchens and retail space.
- Exploring strategic partnerships with institutions like hospitals and schools.
- To prevent reliance on a few key individuals, organizations need robust succession planning. The development of policies and procedures for smooth leadership transitions can ensure long-term stability. Additionally, tracking progress through a shared database can help measure impact and facilitate collaboration

## **Scaling Solutions Despite Market Limitations**

- Leveraging distribution networks to expand market access.
- Identifying and supporting niche products to differentiate from large-scale competitors.
- Enhancing consumer education to create demand for local food.

## **Policy and Advocacy Considerations**

## **Regulatory Challenges**

- Restrictive policies from the BC Vegetable Marketing Commission affecting northern food production.
- Lack of lobbying power among small northern rural farmers compared to corporate interests rooted in the fraser valley area.
- Difficulty navigating government regulations that may deter small producers.

## **Proposed Advocacy Efforts**

- Strengthening farmer representation through coalitions.
- Educating policymakers on regional agricultural needs.

- Using regulatory frameworks to the advantage of local producers (e.g., labeling programs).
- Just do what you need to do in your community instead of waiting for Government to 'approve' - Lead by grass roots not through policy change.

A major recommendation from the meeting was the establishment of a regional food security group to:

- Act as a hub to nurture relationships between organizations.
- Connect resources and funding opportunities.
- Facilitate best practice sharing across communities.

This group would help streamline efforts and ensure that initiatives align with broader regional development goals.

## **Community Engagement and Collaboration**

Lasting change requires buy-in from all sectors. This section emphasizes the value of inclusive, community-rooted approaches that include First Nations leadership, youth engagement, and improved communication tools to build stronger networks.

## **First Nations Involvement**

- Recognizing traditional ecological knowledge in food hub development.
- Building partnerships with First Nations communities from the outset.
- Ensuring equitable representation in food security initiatives.

## **Youth Engagement Strategies**

- Providing hands-on learning experiences in food production.
- Integrating youth into leadership roles within the food strategies.
- Connecting youth with experienced farmers through mentorship programs.

## **Information Sharing and Networking**

## **Developing a Communication Framework**

- Establishing a web-based platform for information sharing.
- Organizing regular meetings and networking events.
- Using collaborative tools like Google Workspace to streamline communication.

## **Regional Collaboration Opportunities**

- Engaging with initiatives like the regional food security coalition in Prince George.
- Learning from other successful models, such as Sprout Kitchen in Quesnel.
- Expanding networking opportunities beyond local boundaries to access more resources.

This group would help streamline efforts and ensure that initiatives align with broader regional development goals.

## **Action Plan and Next Steps**

Turning ideas into action requires clarity, coordination, and commitment. This section offers a roadmap of immediate and long-term strategies to guide the development of food hubs and local food systems in the region.

## **Immediate Action Items**

- Participate in Regional Food Security Coalition (Prince George) Observe and adopt successful practices.
- Engage Business Students for Strategic Planning Partner with institutions to develop sustainable business models.
- Canvas Local Producers Identify needs and preferences for the food security ecosystem.
- **Explore Institutional Contracts** Secure commercial agreements with schools and healthcare facilities.
- **Develop Consumer Education Initiatives** Increase awareness of the benefits of local food.
- Organize advocacy Efforts Advocate for policy changes supporting northern food producers.
- **Strengthen First Nations Partnerships** Ensure meaningful involvement in food planning.
- Enhance Information Sharing Implement digital platforms and regular networking events.
- Plan Next Meeting Set a date for continued discussions and updates (April 24, 2025).

## **Long-Term Strategies**

- Form a Regional Food Coalition: Unify smaller farmers and producers under a collective voice.
- **Develop Sustainable Funding Models**: Identify diverse revenue streams to support food hub operations.
- **Expand Market Access**: Work with distributors and retailers to increase visibility for local food.
- Build capacity in community and across the region rather than wait for government to get behind it.
- Monitor Policy Changes: Stay engaged in advocacy to influence regulatory decisions.

## Conclusion

The consultation meeting highlighted both the opportunities and challenges for food hubs in the region. While there are existing barriers such as funding limitations, regulatory issues, and infrastructure costs, strategic planning and collaboration can address these concerns. By engaging with community stakeholders, forming strong partnerships, and advocating for policy changes, food hubs can become a sustainable and impactful part of the regional food system.

The next steps involve concrete actions such as networking with regional coalitions, developing business strategies, starting small, building with small wins momentum and engaging youth and First Nations communities in meaningful ways. The ultimate goal is to build a resilient and self-sustaining food hub model that enhances food security, strengthens local economies, and fosters community collaboration.

#### **BACKGROUND**

Young Agrarians is a Canada-wide, volunteer-based, organization made up of a variety of people growing food, advocating for food security, and actively participating in and growing food systems and organizations. Agrarians Foundation doing business as Young Agrarians is a registered charity.

The B.C. Land Matching Program has evolved over time – Young Agrarians (YA) began land access programming in 2012. The current program actively connects and supports people who are looking for land to farm, and people who have land available for farming. Land Matchers are available throughout the province to ensure 'personalized, regional matchmaking services for farmers and landholders'[11].

YA has a variety of resources available for both land seekers and landholders, including land matching workshops, a variety of webinars on topics such as farm transition and legal insights for land access, guides and toolkits that include a Farming in Central and Northern B.C. Guide, a team of people dedicated to the program (they are currently hiring a Central & North Land Matcher), and a U-Map that lists both farmers looking for land and land listings. At present, we have six people looking for land, and seven land listings within our region<sup>[2]</sup>.

#### **BACKGROUND**

As requested at the September 4, 2025 Committee of the Whole meeting, staff have prepared an overview of the Premier's Task Force on Agriculture and Food Economy.

The Task Force was established by the Government of British Columbia in February 2025 to provide external policy advice on strengthening B.C.'s agriculture and food sectors. It is composed of 16 members representing producers, processors, labour, retail/sales, academia, First Nations, and industry associations.

The Task Force is co-chaired by: Danielle Synotte, Executive Director, BC Agriculture Council, James Donaldson, CEO, BC Food & Beverage, and Michelle Koski, Deputy Minister, Ministry of Agriculture and Food.

#### **Mandate & Focus Areas**

The Task Force has been asked to produce prioritized, actionable recommendations for government in five key areas: water, competitiveness, labour, land, and investment.

The goal is to enable efficient decision-making, support timely implementation, and set a 'measurable long-term vision for sector growth and competitiveness'[1].

## **Key Recommendations to Date**

### Water

- Prioritize Water, Land and Resource Stewardship (WLRS) permitting for water storage capacity at farm, community, and watershed levels (using both infrastructure and naturebased solutions). Also prioritize water storage projects in Ministry of Agriculture and Food funding programs.
- Streamline Dam Safety Regulation requirements for lower-risk water infrastructure look to streamline the permitting process.

- Create pathways to low-interest public and private financing for community-level agricultural water projects.
- Clear the backlog of groundwater applications submitted before the deadline in 2022.
- Create a new framework for assessing applications received after the 2022 deadline that streamlines the authorization process.
- Incentivize groundwater licensing by linking possession of a water license to eligibility for government programs.
- The agriculture sector should be represented in watershed planning processes, in particular, government forums. Farmer and rancher participation ensures collaborative problem solving. Government should provide community-level watershed planning processes with the appropriate technical knowledge resources, and a streamlined toolkit.
- Reserve and protect water for agricultural use.
- Develop guidelines at the provincial level that require local government to have a key role in region-specific planning and infrastructure to ensure agricultural water security.

## **Competitiveness**

- Work with the agriculture industry to target government resources toward subsectors, businesses, products and regional clusters with highest sustainable growth potential.
- Eliminate Provincial Sales Tax on agriculture, aquaculture, and food inputs/equipment.
- Remove the motor fuel tax paid by seafood producers.
- Introduce a provincial investment tax credit that can be used to encourage producers and processors to modernize and adopt new technologies.
- Advocate to the Federal Government to continue the Accelerated Investment Incentive for Capital Cost Allowance.
- Provide access to funding to de-risk investments and support technology demonstration projects.
- Reduce regulatory burden for producers and processors.

## **Next Steps**

The Task Force will continue to meet through January 2026. Future recommendations will address labour, land, and investment priorities.
