The Evacuation Alert issued on **December 28, 2025 at 1600 hours** by the Regional District of Bulkley-Nechako has been rescinded in its entirety. This covers the following area:

**All lands, properties, and dwellings north of Dohler Road and the lands south of Dohler Road that are located east of Rosenthal Subdivision Road as shown on the attached map.**

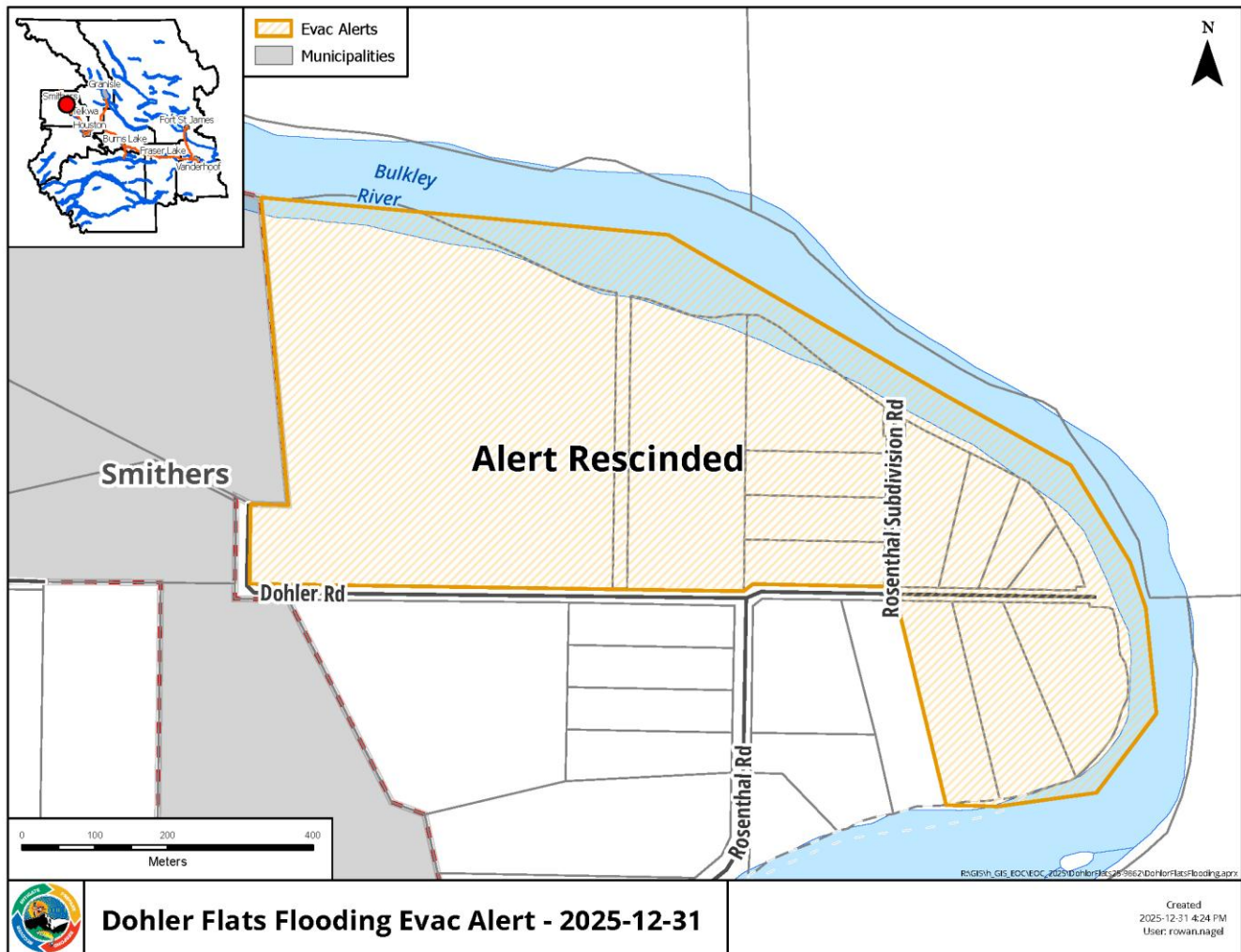

# EVACUATION ALERT

## Dohler Flats Flooding December 28, 2025, at 1600 hours

An Evacuation Alert has been issued by the Regional District of Bulkley-Nechako (RDBN) effective December 28, 2025, at 1600hrs due to the growing concern of **ice jams on the Bulkley River causing flooding.**

Because of the potential **danger to life and health**, the Regional District of Bulkley-Nechako has issued an Evacuation Alert for the Dohler Flats Area, **for all lands, properties, and dwellings north of Dohler Road and the lands south of Dohler Road that are located east of Rosenthal Subdivision Road as shown on the attached map.**

An Evacuation Alert has been issued to prepare you to evacuate your premises, or property should it be found necessary. Residents will be given as much advance notice as possible prior to evacuation, however, you may receive limited notice due to changing conditions.

### WHAT YOU SHOULD DO WHILE THIS ALERT IS IN EFFECT

Be prepared for an Evacuation Order:

- Locate all family members or co-workers and plan to meet outside the evacuation area, should an evacuation be called while separated.
- Gather essential items such as medications, eyeglasses, valuable papers (i.e., insurance), immediate care needs for dependents and, if you choose, keepsakes (photographs, etc.), and have these items readily available for quick departure.
- Prepare to move any persons with mobility challenges and/or children.
- Move pets and livestock to a safe area. If you require assistance, please call the Regional District of Bulkley-Nechako.
- Arrange to transport your household members or co-workers in the event of an evacuation order. If you are asked to evacuate and need transportation assistance from the area, please call the Regional District of Bulkley-Nechako.
- Arrange accommodation for your family if possible.

In the event of an Evacuation Order, a Reception Centre will be opened if required, and evacuation routes specified.

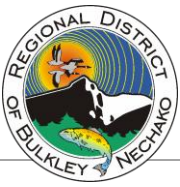

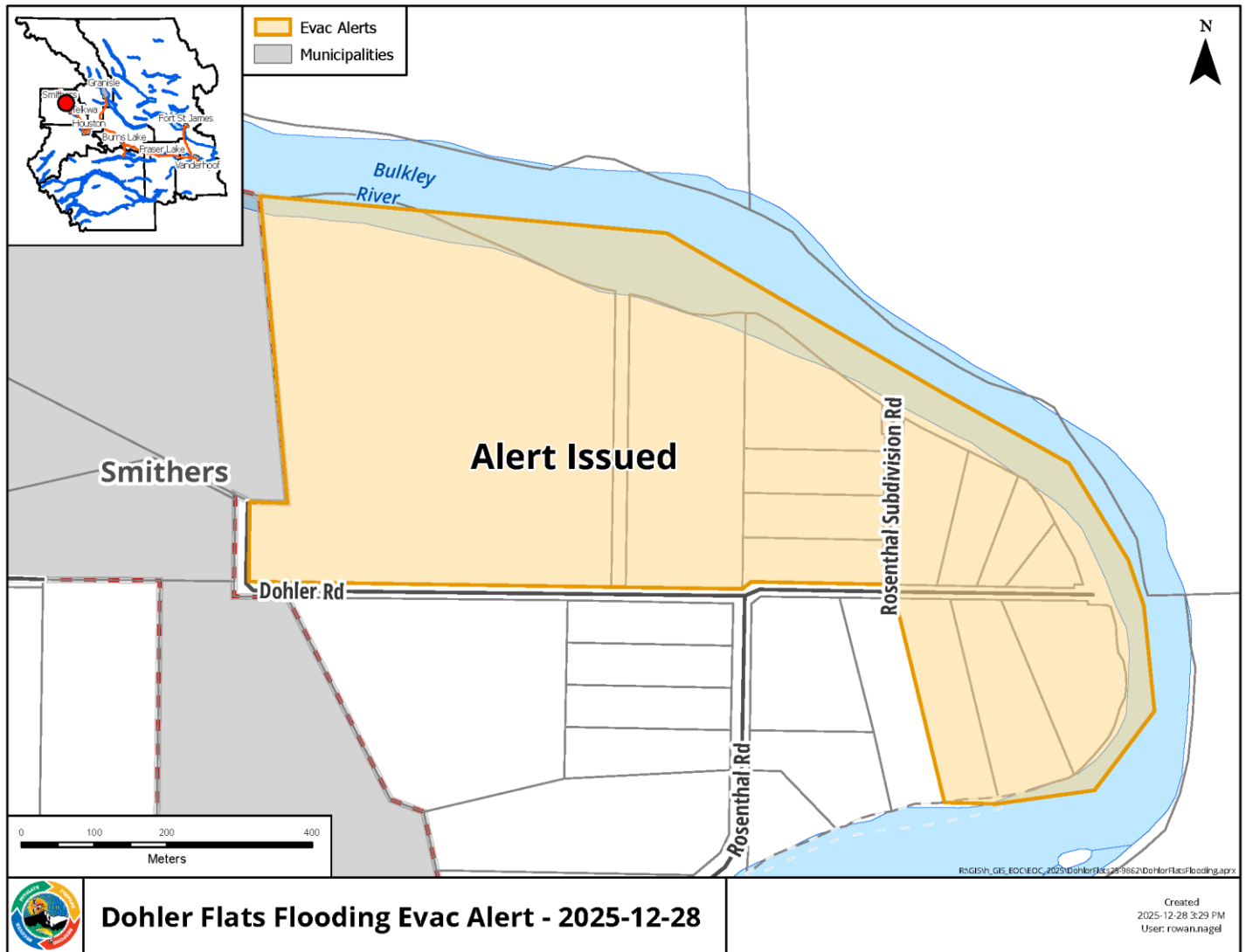
