Water Filling Station Now Open in Fort St. James

Fort St. James, B.C. – The Regional District of Bulkley-Nechako and the District of Fort St. James are pleased to be partners on the installation of a metered water filling station. This station provides rural residents access to potable water from the District of Fort St. James' water distribution system. The water station is located at 300 Stuart Drive E., next to the Fort Forum Arena.

Installation of the system was cost-shared by the District of Fort St. James and Regional District of Bulkley-Nechako Electoral Area C (Fort St. James Rural). The Area C contribution was made through a Canada Community-Building Fund BC grant. Residents will be able to use the system's on-site point-of-sale system with either their debit or credit card, or by setting up an account with the District of Fort St. James, to access potable water for tanks or other containers for their homes. The rate for one cubic meter (1,000 litres) of water is \$13.34.

Drought conditions across BC in recent years have significantly impacted well reserves for rural residents in Electoral Area C (Fort St. James Rural). This new automated system, operated by the District of Fort St. James, will ensure that residents from outside the municipality can access affordable, potable water 24 hours a day, 7 days a week.
